
INCORPORATION OF MASTER FORM PROVISIONS

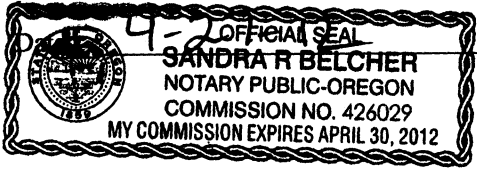
