AGREEMENT TO CORRECT EASEMENT DEED

WHEREAS, PacifiCorp, a corporation of the State of Oregon, doing business as Pacific Power, successor in interest to PacifiCorp, a corporation of the State of Oregon doing business as Pacific Power & Light, a corporation of the State of Maine, Grantor, conveyed to the **United States of America**, an easement for portions of Road No. 30, by deed dated August 20, 2004, recorded February 4, 2009, as Auditor's File Number 2009172003, of the official records of Skamania County, State of Washington; and,

WHEREAS, the Easement Deed contains certain errors which, if not corrected, will prevent that document from reflecting the true agreement of the parties in all respects.

NOW THEREFORE, the aforementioned Easement Deed dated August 20, 2004, recorded February 4, 2009, as AFN 2009172003, executed by **PacifiCorp** to the **United States of America**, is hereby amended as follows:

1. The legal description below the second paragraph of page 1 is deleted and replaced with: "T. 7 N., R. 5 E., W.M., sec. 25, NE1/4NW1/4"
2. In the second paragraph under section A, fourth line on the second page, the word "trail" is deleted and replaced with the word "easement"
3. In the second paragraph under section B.2., "26 CFR 212.7(d)" is deleted and replaced with "36 CFR 212.7(d)"

Except as amended by this Agreement to Correct Easement Deed, all other terms and conditions of said Easement Deed dated August 20, 2004, recorded February 4, 2009, as AFN 2009172003 referenced above, shall remain in full force and effect.

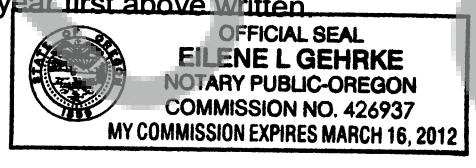

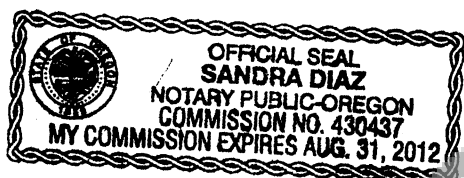
