to construct, reconstruct, rephrase, repair, operate, and maintain an underground electric distribution line or system or water line upon the land described above and along all highways, roads or driveways abutting or upon said lands; and to cut, trim, and remove those trees and shrubbery located within 10 feet of the center line of said line or system, by machinery or otherwise, which interfere with the safe and prudent operation of said electric distribution line or system or water line or system.

The undersigned agree that all pipes, wires, and other facilities, including any main service entrance equipment installed on the above-described lands by Skamania PUD or at its expense, shall be and remain the property of Skamania PUD and shall be removable at its option.
