THIS MODIFICATION OF DEED OF TRUST dated April 23, 2013, is made and executed between Samuel J Seaman, whose address is 922 High Bridge RD, Carson, WA 98610 and Blanche Seaman, whose address is 922 High Bridge RD, Carson, WA 98610 ("Grantor") and Riverview Community Bank, whose address is PO Box 872290, Vancouver, WA 98687-2290 ("Lender").

DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated April 12, 2002 (the "Deed of Trust") which has been recorded in Skamania County, State of Washington, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Skamania County, State of Washington:

A tract of land in the Southwest Quarter of the Southwest Quarter of Section 8, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington described as follows:

Beginning at the intersection of the North line of Government lot 4 of said Section 8, with the East line of the Wind River Road as it existed in 1960; thence East of the North line of Lot 4, a distance of 300 feet; thence South to the intersection with the Easterly edge of the aforesaid road; thence Northwesterly along the Easterly edge of said road to the point of beginning.

The Real Property or its address is commonly known as 922 High Bridge RD, Carson, WA 98610. The Real Property tax identification number is 03-08-08-3-0-0400-00.

MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

All Reference to "Variable Interest Rate" and revolving Line of Credit is eliminated.


Modifying Loan amount to: \$12,982.81.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorser to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.



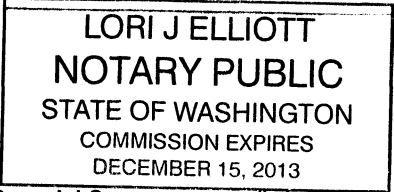


