PROPERTY MANAGEMENT AGREEMENT

THIS Property Management Agreement is by and between certain beneficiaries of the Sherry Lorraine Homan Trust Agreement for management of certain property located near Willard, Washington more particularly described in Exhibit "A" attached hereto. This agreement is for all the parties and specifically for the protection of Wayne Homan and Jo.Ann Homan who are residing on the said real property.

The real property has two houses that are each situated upon acreage. The property has timber. Except as provided in this agreement, Wayne Homan and his wife Jo.Ann Homan have a life estate in an undivided one half of the said real property; and Brent Homan has a life estate in an undivided one half of the said real property.

As between the parties to this agreement, it is agreed as follows:

- Wayne Homan and his wife Jo.Ann Homan for their lifetimes shall have the right to exclusive use of the garage and home located at 1422 Oklahoma Rd., Willard, WA including an exclusive easement for the access road, and including the land area starting at the Little White Salmon River and county road, going North 325 feet, then East 225 feet to the small creek on the property and following the creek South till it flows into the Little White Salmon River.
- Brent Homan for his lifetime shall have exclusive use of the house located at 1512 Oklahoma Road, Willard, WA including exclusive rights to the easement for access from the county road (approximately 1500 feet long access road), and including the land area of 300 feet diameter centered at the house.
- 3. After Wayne Homan and Jo.Ann Homan are both deceased, Nathaniel Homan, Bryana Homan and Sandra Homan shall jointly have the exclusive use described in paragraph 1 above.
