Fahrni (which is recorded on _____, in Volume ____ of Mortgages, Page _____, under Auditor's file number 20/3 00/3/7, records of Skamania County) (which is to be recorded concurrently herewith).
- 3. Audrey D Fahrni and Daniel C Fahrni referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in paragraph 2.
- 4.
