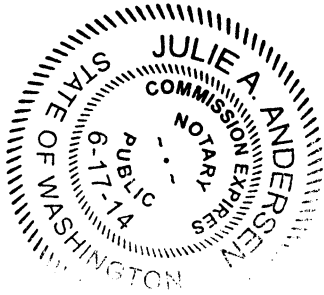


EXHIBIT A

A parcel of land situated within Government Lot 3, Section 2, Township 3 North, Range 10 East, of the Willamette Meridian, in the County of Skamania and the State of Washington and described as:

That portion of Tract B of the Ostermann Short Plat as shown on the map thereof recorded in Book 1 at Page 21f of Short Plats, Auditor's File Number 81255, PLUS that portion of Lot 2 of the Verley Short Plat as shown on the map thereof recorded in Book 3 at Page 52 of Short Plats, Auditor's file Number 96259, and described more particularly as follows:

Commencing at the Northwest corner of said Tract B (which is marked with an iron rod), thence North $88^{\circ} 53' 36''$ East 340.66 feet along the North line thereof to the Easterly edge of a 60-foot right of way for Ostermann Road, which is a point on a curve concave to the West and having a radius of 914.5 feet (the radial bearing of which bears South $75^{\circ} 15' 45''$ West), thence Southerly along said curve through a central angle of $21^{\circ} 17' 23''$ in a distance of 339.81 feet (the chord of which bears South $04^{\circ} 16' 23''$ East 337.86 feet), and the Point of Beginning; thence continuing along said curve through a central angle of $3^{\circ} 39' 43''$, a distance of 58.45 feet (the chord of which bears South $09^{\circ} 23' 40''$ West, 58.44 feet); thence South $88^{\circ} 52' 09''$ West, 30.64 feet to the centerline of said road; thence along the centerline of said road, South $10^{\circ} 35' 32''$ West, 131.56 feet to the beginning of a curve concave to the Northeast and having a radius of 73.24 feet; thence Southerly and Easterly along said curve through a central angle of $101^{\circ} 43' 33''$, a distance of 130.03 feet (the chord of which bears South $40^{\circ} 16' 09''$ East, 113.62 feet); thence North $88^{\circ} 52' 09''$ East, 99.37 feet to an intersection with the centerline of Lakeview Road No. 32510; thence South $61^{\circ} 06' 37''$ East, 30 feet to the Southeasterly edge of said road; thence South $28^{\circ} 53' 23''$ West, 17.31 feet along said road to the South line of said Lot 2; thence South $88^{\circ} 52' 09''$ West, 302.35 feet to the Southwest corner thereof; thence North $02^{\circ} 11' 04''$ West, 246.98 feet along the Westerly line thereof to the South line of said Tract B; thence South $88^{\circ} 52' 09''$ West, 165.50 feet to the Southwest corner of said Tract B; thence North $02^{\circ} 10' 04''$ West, 254.01 feet along the West line thereof to a point lying 150 feet South of the Point of Commencement; thence South $63^{\circ} 23' 05''$ East, 402.78 feet to the point of beginning;
