NOTICE HEREBY IS GIVEN that the undersigned locators, each a citizen of the United States or one who has declared an intention to become such, have discovered on August 7, 2013, a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and in accordance with the laws of the United States and of the State of Washington, have located and do hereby locate a placer claim of 20 acres by posting this notice of location on a substantial post or monument in a conspicuous place at the point of discovery inside the boundaries of the claim.

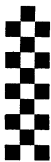
(1) If location is made in conformity with public surveys:

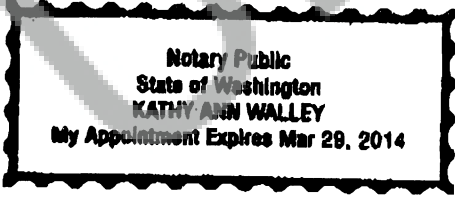
