

**NARRATIVE:**  
 THE PURPOSE OF THIS SURVEY WAS TO DETERMINE THE BOUNDARY OF THE REFERENCED DEED PARCELS, AND TO CALCULATE AND MONUMENT A BOUNDARY LINE. ADJUSTMENT BETWEEN THEM AS SHOWN HEREON. AN ELECTRONIC COORDINATE MODEL WAS DEVELOPED FROM R.O.S. BK. 1, PG. 82 AND FROM SHORT PLAT BK. 2, PG. 16. FIELD WORK CONSISTED OF A CLOSED LOOP TRAVERSE AROUND THE "SWEET" PARCEL WITH RADIAL TIES MADE TO FOUND MONUMENTS. THE TRAVERSE AND TIES WERE THEN ORIENTED BETWEEN EXISTING MONUMENTS AT THE NE CORNER AND AT THE SOUTHERLY CORNER OF LOT 5 AS SHOWN IN R.O.S. BK. 1, PG. 82 AS MODELED AND NOTED HEREON AS HELD. FOUND IRON RODS FIT THEIR MODELED POSITION WITHIN 0.23". THE IRON RODS AND GALVANIZED NAILS WERE SET BY RADIAL STAKEOUT FROM THE TRAVERSE POINTS.

**\*BASIS OF BEARINGS**

THE CALCULATED BEARING OF N183°44'48"E BETWEEN EXISTING MONUMENTS (1/2" IRON RODS) AT THE NE CORNER AND AT THE SOUTHERLY MOST CORNER OF PARCEL "5" AS SHOWN IN R.O.S. BK. 1, PG. 82 AND NOTED HEREON AS HELD. (SEE NARRATIVE)

**PROCEDURE**

THE FIELD TRAVERSE WAS PERFORMED USING A 3-SECOND "TOTAL STATION" INSTRUMENT. THE TRAVERSE WAS ADJUSTED BY COMPASS RULE AND THE RESULTING LINEAR ERROR OF CLOSURE WAS EQUAL TO OR EXCEEDED THE REQUIREMENTS OF IAC 332-130-090. (SEE NARRATIVE)



