 Drive, specifically the South half of the Southeast quarter of section 28, Township 2 North, Range 5 East,
 Willamette Meridian, and all lots within Stone Land Short Plat, hereinafter "landowners," shall be
 responsible for the cost of maintaining and repairing the road, with the cost shared equally by each lot
 accessed by Stone Drive.
- 2. If any of the parcels served by Stone Drive is subdivided, each newly created lot shall be added to the calculations when computing equal shares.
