- 2. Stop sign at Upland and Jennifer Way along River Road.
- 3. Steel barrier on River Road.
- 4. Road clean-up (pot holes, blackberries, tree limbs, cul-du-sac maintenance, mailbox clean-up, etc)

Liability Insurance Report by Patrick Luft (Director)

- 1. Researched liability insurance at Liberty Mutual, State Farm, Country Financial, and an independent broker because this is a goal set at the General Meeting in 2012.
- 2. Liberty Mutual, State Farm, and Country Financial declined insuring the REA because the well is not independently monitored.
- 3. The independent broker quoted a \$1000 a year for liability insurance provided the reservoir is maintained and the gun ordinance is in effect. If either of these conditions change, the quote will be revisited.

Change in Voting Method presented by Bonnie Carter (Sectretary/Treasurer)
Per the suggestion of a member who did not want his/her vote made public, voting was done by secret ballot. The ballots contained a lot number, so to keep the vote secret the ballots were randomly handed out and do not reflect the vote of the numbered lot. Keith Groves also pointed out a written candidate could be added with the secret ballot. The ballots were counted by Bonnie Carter (Secretary/Treasurer) and reaffirmed by Tom Smart (President). For each vote there is an envelope citing the item to be voted on and the signatures of Carter and Smart. The individual ballots are sealed in the envelope.

Agenda presented by Tom Smart (President)

1. Governing Body changes to the REA By-laws: The current By-Laws call for the Board of Directors (3 year, 2 year and one year terms respectfully) to govern the REA. The membership votes in favor of changing the Board of Directors as defined in the By-Laws to the Directors & Officers Group

consisting of a 3-year Director, 2-year Director, 1 year Director, 1 year each for the positions of President, Vice-President and Secretary/Treasurer.

2. The membership voted in favor of the following duties to be added to the REA By-Law in Article $\dot{\text{VI}}$, Section 6, d. Treasurer maintaining a checks and balances in the REA financial system,

- i. Outgoing checks will be signed by two officers. A physical or digital copy of each check must be maintained along with back up invoices for member review.
- ii. Incoming checks from members must be copied either physically or digitally and maintained in a notebook or file for member review.

iii. Sending out monthly statements.

- b. The Treasurer be responsible for posting a letter/newsletter to Association members in January with State of the Association:

 - i. The amount in the General Fund and the amount in the Well Fundii. The amount of money owed the Association and the progress of and promissory notes.
 - iii. The actual expenditures for the previous year.

iv. The budget for the upcoming year.

3. The REA membership votes in favor of adding the office(s) of Road Commissioner and Water/Well Commissioner as non-voting members of the REA Director & Officers Group. These commissioners would report to the Director & Officers Group. This will allow each Commissioner to call individual member meetings about their issues and report solutions to the Directors & Officers Group for final action.

These changes will be recorded with Skamania County, Recorders Office.

4. The membership voted in favor of increasing the General Fund assessment beginning January 1, 2014 from \$20.00 a month to \$25.00. The following annual expenses indicated that future road maintenance, tree removal, snow removal, and miscellaneous expenses called for an increase.

The following ordinances were passed by a majority vote on December 30, 1990, and reaffirmed on May 23, 1992:

Ordinance #1. The discharging of fire arm, rifle or hand gun and/or any such weapon thereof, is strictly prohibited.

Ordinance #2. The use of all-terrain, trail bikes, three or four wheeled off-road vehicles and/or any unlicensed motor vehicles are prohibited on any private road or common areas of the Riverside Estates Association.

Ordinance #3. All domestic pets are to be either contained on the premises of owners or under direct control of owners when off said

The following ordinance was passed by unanimous vote on January 12,

Orinance #4. Common area "B", Federal/State Wetland, is restricted to immediate families members only, immediate referring to husband, wife, children. Also, no child under the age of twelve years be allowed access to said area without the accompaniment of an adult.

In April 2013 another member of the REA challenged the Ordinances. In their investigation documents were uncovered that show the January 12, 1994 meeting was held null & void in a Judgment Order from Skamania County. Consequently Ordinance #4 is Null & Void. No other documents have been found to date indicating any other changes. Ordinances 1, 2 and 3 stand is as part of the REA CCRs, By-Laws, and other documents unless other documents indicate otherwise. All correspondence regarding this challenge is in the Communications section of the 2013 REA Book (available to review by any member).

As a result of this fact finding mission, the Skamania County Recording Office emailed the REA documents filed in that office to the REA. These documents were

6. Well Report was presented by Tom Smart (President/Well Commissioner)

- 1. The well is being checked by Hall & Sons this week. Their recommendations will be considered by the Well Commissioner and recommendations forth coming.
- 2. Tom suggested the gate valves be changed to ball valves.
- 3. Vicki suggested a alarm on the door(s) for safety. Gary said a lock box might be a better solution. All items to be considered by the Well Commissioner.

7. Neighborhood Watch Report ... Patrick Luft (Director)

- 1. A car was cited in front of the Warren property. The Skamania County Fish Hatchery called the police and the REA called the police with the license number of the car giving the police what they needed to take action.
- 2. A truck was parked alongside River Road for a few days. The police were notified but by the time action could be taken the owner of the truck moved it.
- 3. The Capron's reported an attempted break in to their home. The Skamania County police have been patrolling the REA roads.
- 4. Last Friday night two persons in a van (identified by the police as the same two who were fishing on the Warren property) were stuck on Jennifer Way and the Perlot driveway in a ditch. The police were unable to remove the vehicle because it had no outstanding warrants. The persons were identified by the police as known drug users. The REA paid to have the van towed off our private roads. The police said once the vehicle hit a public road they would take over.

The Neighborhood watch is working. We continue as a group to send the message "take your business elsewhere".
