

# MEMORANDUM OF AMENDED AND RESTATED CONSERVATION EASEMENT PURCHASE AND SALE AGREEMENT

POPE RESOURCES, a Delaware limited partnership ("Seller"), located at 19950 7th Avenue N.E., Suite 200, Poulsbo, WA 98370, and COLUMBIA LAND TRUST, a Washington nonprofit corporation ("Buyer"), located at 1351 Officers Row, Vancouver, WA 98661, have entered into an Amended and Restated Conservation Easement Purchase and Sale Agreement dated of approximately even date herewith ("the "Purchase and Sale Agreement"), wherein Seller has agreed to sell to Buyer and Buyer has agreed to purchase from Seller on or before December 12, 2014, a conservation easement with respect to that certain real property situated in Skamania County, Washington (the "Property"), which Property is more fully described on Exhibit "A" attached hereto and made a part hereof for all purposes. The terms and conditions of the purchase and sale are more particularly described in the Purchase and Sale Agreement, to which reference is here made for all purposes.

This Memorandum is being executed and recorded in the Official Records of Skamania County, Washington, in order to give notice of the provisions of the Purchase and Sale Agreement, and this Memorandum should not be deemed or construed to define, limit or modify the Purchase and Sale Agreement in any manner. This Memorandum is intended to amend, replace and supersede in the entirety that certain Memorandum of Agreement recorded in the Official Records of Skamania County, Washington, under Fee No. 2013000239.

The parties have executed this Memorandum as of March 14, 2014.

## **DESCRIPTION/DEPICTION OF PINE CREEK WEST**

A tract of land located in a portion of Sections 4, 5, 6, 8, 9, 15, 16, 17 and 23, Township 7 North, Range 6 East, Willamette Meridian, Skamania County, Washington, being a portion of the land described in the "Second Revised Division Map of Swift North", according to the plat thereof, recorded in Auditor's file number 2013000822, Records of Skamania County, Washington, and in deed recorded in Auditor's file number 2013000915 and correction deed recorded in Auditor's file number 2013000990, more particularly described as follows:
