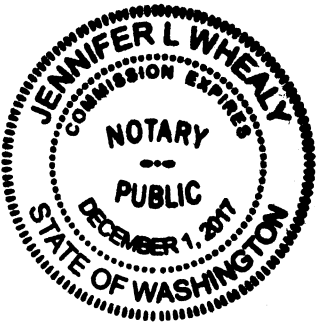
Said liens are recorded in the office of the Skamania County Auditor as listed above.

This release shall not impair the validity of any other lien for deferred property taxes and/or special assessments which may, now or in the future, be claimed against the above-described property.


