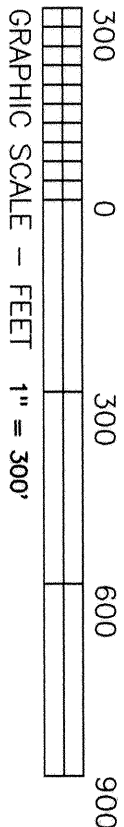

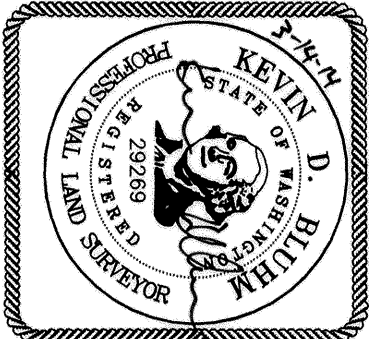
FIELD TRAVERSE USING A TOPCON GTS-225 (00°00'10") TOTAL

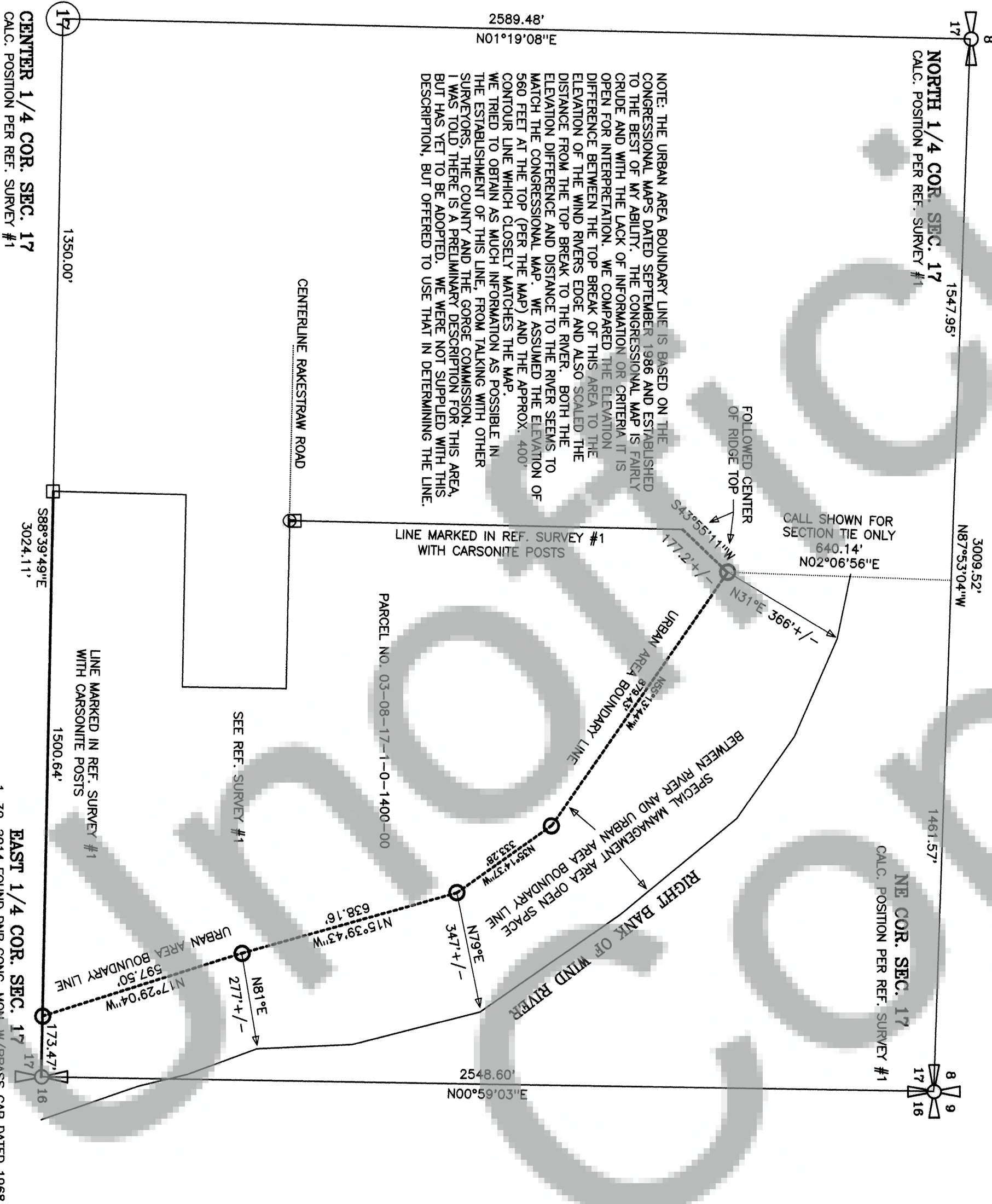
