KNOW ALL MEN BY THESE PRESENTS: That I, WILLIAM J. WILKINSON, a resident of Skamania County, Washington, being of sound and disposing mind and memory, and not acting under duress, menace, fraud or the undue influence of any person whomsoever, do make, publish and declare this my Last Will and Testament, and do hereby revoke all former Wills or Codicils made by me.

I

I hereby declare that I am married to Marjorie E. Wilkinson, and that I am the father of four children, namely: Richard W. Wilkinson, Shannon L. Wilkinson, Randall E. Wilkinson, and Candace R. Wilkinson, all of whom have attained majority.

II

I direct that my Executor, hereinafter named, pay as promptly as possible, all of my just debts and obligations, and my funeral expenses and expenses of last illness, provided, that this directive shall not require the payment of any debt or obligation prior to its normal maturity.


III

I here and now nominate and appoint my son, Randall E. Wilkinson, to be and act as Executor of this, my Last Will and Testament, to act without bond, and I further direct that this Will shall be construed to be a Non-intervention Will, and that it shall be settled without the intervention of any court or courts except as provided by Chapter 11.68, Revised Code of Washington.

I give to my Executor absolute power to hold, sell, mortgage and encumber my property, and to invest and reinvest the proceeds thereof, to continue operation of any business enterprise I may own, or to sell or liquidate the same, and in the conduct of such business to hire such help, employees and agents as he deems necessary, all as he, in his absolute discretion sees fit.

Pursuant to RCW 11.12.260, I may prepare and sign a writing whereby I provide for the disposition of my household goods and furniture, my personal effects, and other items of

personal property. I expressly reserve the right to revoke, alter, add to or strike from said extrinsic writing from time to time at any time.

I hereby authorize and direct my Executor in making distribution under this, my Last Will and Testament, to deliver possession of the personal property specified in such extrinsic writing to the persons named therein. I further absolve my said Executor from all responsibility and liability in locating, marshalling and accounting for such personal property. All of my personal property not specifically mentioned in such extrinsic writing shall pass under the residuary clause of this, my Last Will and Testament.

I make no provision for my wife, Marjorie E. Wilkinson.

VI

Except for tangible items of personal property disposed of pursuant to Article IV, of this, my Last Will and Testament, I make no provision for my son, Richard W. Wilkinson, or my daughters, Candace R. Wilkinson and Shannon L. Wilkinson.

VII

I give, devise and bequeath all of the rest, residue and remainder of my property, real, personal or mixed, and wherever situate, and all of my interests in any property of every kind, make and description unto my son, Randall E. Wilkinson.
