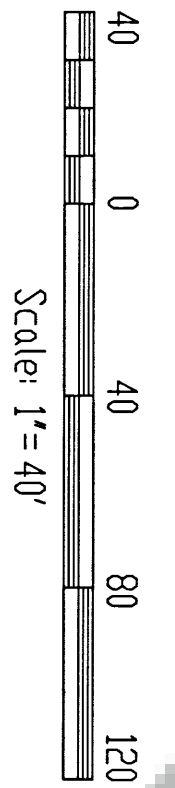

DATE SURVEY MONUMENTATION: JULY 8, 2014

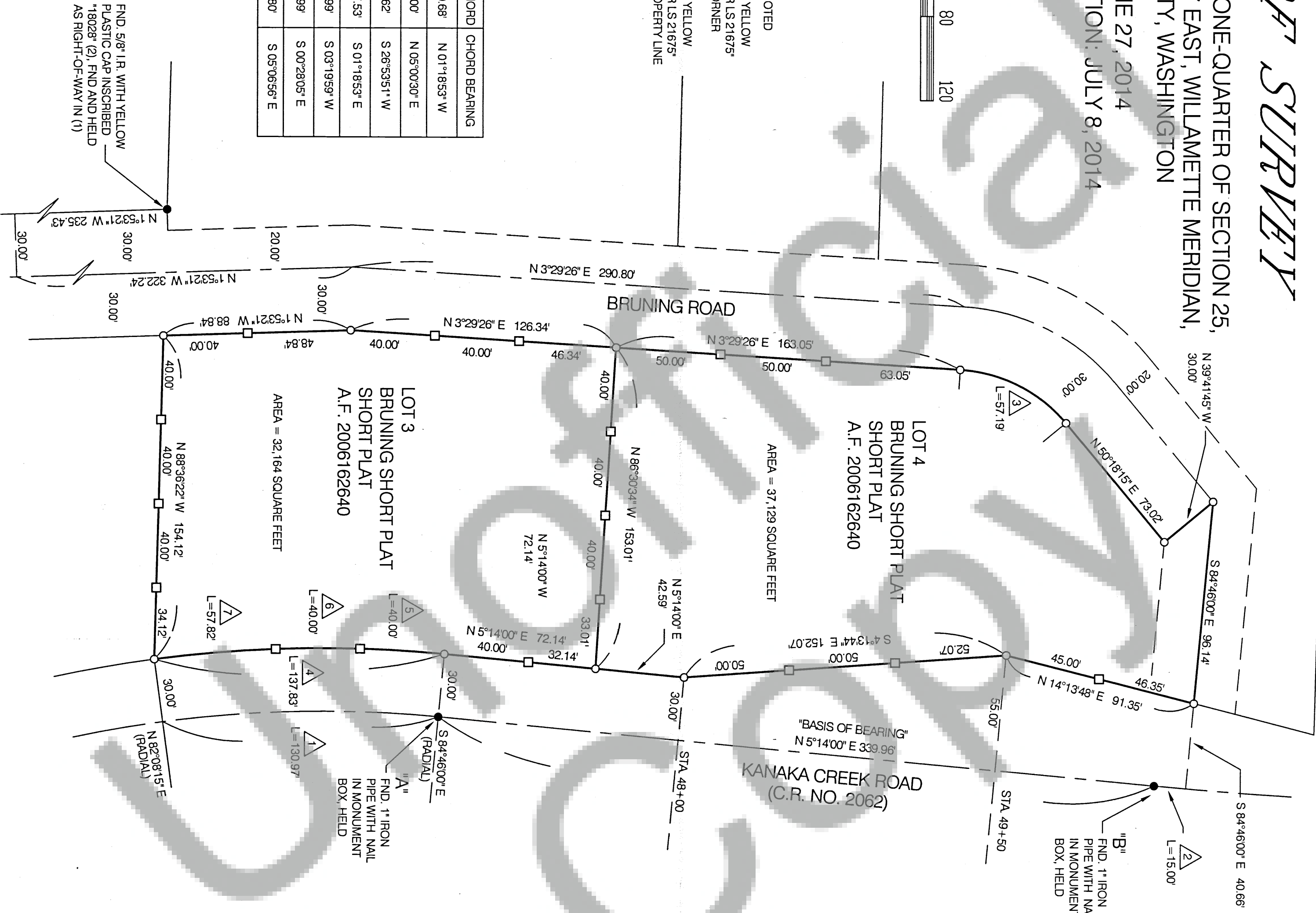

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO LOCATE THE MONUMENTS FOR LOT 3 AND 4 OF THE BRUNNING SHORT PLAT AS RECORDED IN AUDITORS FILE NO. 2006-162640, SKAMANIA COUNTY RECORDS. AFTER SEARCHING FOR THE MONUMENTS IT WAS DISCOVERED THAT THE MONUMENTS HAD NOT BEEN SET FOR WHATEVER REASON. THEREFORE WE SET THE MISSING CORNERS OF LOTS 3 AND 4 ALONG WITH ADDITIONAL MONUMENTS ON PROPERTY LINES AS DIRECTED BY OUR CLIENT. FOR MY BASIS OF BEARING I HELD THE RECORD BEARING ALONG THE CENTERLINE OF KANAKA CREEK ROAD BETWEEN THE TWO FOUND AND HELD MONUMENTS LABELED HEREON AS POINTS "A" AND "B". PER SAID RECORDED SHORT PLAT, I THEN HELD SAID SHORT PLAT IN ITS ENTIRETY AND SET THE MISSING CORNERS AS SHOWN, FINDING THE ADDITIONAL MONUMENTS ALSO AS SHOWN HEREON.

EQUIPMENT USED

A FIELD TRAVERSE WAS PERFORMED USING A FIVE SECOND THEODOLITE AND AN ELECTRONIC DISTANCE MEASURING UNIT (TOTAL STATION). THE FIELD TRAVERSE MET THE MINIMUM STANDARDS FOR SURVEYS AS DESIGNATED IN WAC 332-130-090. ALL CORNERS NOTED AS FOUND WERE VISITED AT THE TIME OF THIS SURVEY.
