**Easement for Ingress and Egress and Utilities**

THE GRANTOR, MARK HINKLE, owner of the Lot 2 of VENADO RANCH ESTATES Short Plat (03072530011400) hereby conveys to the GRANTEE, RUSSELL D. GAYNOR, owner of Lot 4 of KANAKA HEIGHTS SHORT PLAT (03072530011900), their successors and assigns, a non-exclusive easement over and across the following described real property, located in Section 25 of Township 3 North, Range 7 East of the Willamette Meridian in Skamania County Washington; for the purpose of ingress, egress, utilities and use, maintenance and improvements of the spring located in said easement; more particularly described as follows:

Beginning at a point which is North 88°49'33" West, a distance of 50.00 feet from the Northeast corner of Lot 2 of VENADO RANCH ESTATES monumented by a Red Plastic Cap on a 5/8 rebar;  
thence South 00°53'58" West, a distance of 50.00 feet;  
thence South 89°06'02" East, a distance of 20.00 feet;  
thence South 00°53'58" West, a distance of 18.39 feet;  
thence North 88°49'33" West, a distance of 31.07 feet to a Red Plastic Cap on a 5/8" rebar;  
thence North 47°27'03" West, a distance of 103.33 feet more or less to the south line of LOT 4 OF KANAKA HEIGHTS SHORT PLAT;  
thence South 88°49'33" East along said south line of lot 4, a distance of 88.29 feet to the Point of Beginning.

AND: Said easement allows that:


- 1) Both parties have the right to improve the existing road and install any utilities in said easement.
- 2) The granting of this easement does not prohibit the Grantor from utilizing said improved road.
- 3) The granting of this easement does not prohibit the Grantor from assigning to others the use of said easement and improvements.
- 4) The granting of this easement does not alter any other rights over the described area that may exist in favor of others not named in this agreement.
