**"THE PURPOSE OF THIS DEED IS TO AFFECT A BOUNDARY LINE ADJUSTMENT BETWEEN ADJOINING PARCELS OF LAND OWNED BY THE GRANTOR AND GRANTEE; IT IS NOT INTENDED TO CREATE A SEPARATE PARCEL, AND IS THEREFORE EXEMPT FROM THE REQUIREMENTS OF RCW 58.17 AND THE SKAMANIA COUNTY SHORT PLAT ORDINANCE. THE PROPERTY DESCRIBED IN THIS DEED CANNOT BE SEGREGATED AND SOLD WITHOUT CONFORMING TO THE STATE OF WASHINGTON AND SKAMANIA COUNTY SUBDIVISION LAWS."**

**ATTACHMENT NO. 1****Pine Creek West and Other Timberlands: Description of Parcels Conveyed and Supplemented**

The following is a description of the parcels being conveyed and the parcels to which they are being added. This Attachment No. 1 is intended to satisfy the requirements of Skamania County Code Section 17.68.030.B and is not intended to provide the legal description of the real property conveyed by this deed.

**STATUTORY WARRANTY DEED  
AND BOUNDARY LINE ADJUSTMENT  
(Pine Creek West and Other Timberlands: 2014 Third Revised Exempt Division of Swift North)**

Pope Resources, a Delaware limited partnership ("Pope Resources"), and Columbia Land Trust, a Washington nonprofit corporation ("Columbia Land Trust"), executed a Third Revised Division Map of Swift North, which was recorded in the real property records of Skamania County on December 22, 2014, under Auditor's File No. 2014 002266 (the "Swift North Division Map"). Pope Resources owns that portion of the real property subject to the Swift North Division Map that is described in this deed as the Property, which is commonly known as Pine Creek West and Other Timberlands.

This deed is given by Pope Resources to confirm the consolidation and division of the Property as described on the Swift North Division Map. The making and recording of this deed confirms but does not amend, replace, or supersede the Swift North Division Map and does not modify the legal effect of the Swift North Division Map. Pope Resources does not waive any rights relating to the Swift North Division Map.

To the extent that there may be any conflict between this deed and any prior deed given by Pope Resources and recorded in the real property records of Skamania County, Washington, as to the description of the real property described in this deed, this deed shall control and all prior deeds given by Pope Resources shall be deemed amended, corrected, and revised.

Now, therefore, Pope Resources hereby conveys and warrants to Pope Resources the real estate situated in the County of Skamania, State of Washington, described on Exhibit A attached hereto (the "Property"), consolidated and divided into lots as described on such exhibit and on the Swift North Division Map, subject to all agreements, conditions, covenants, declarations, division maps, easements, encumbrances, restrictions, and other matters of record.

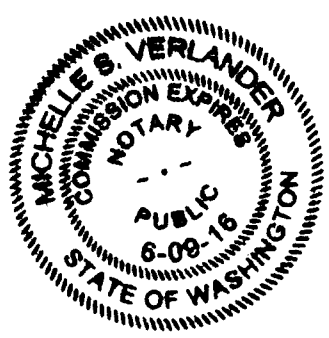


