DECLARATION OF COVENANT Public Water Source

I (we), the undersigned, owner(s) in fee simple of the land described herein, hereby declare this covenant and place same on record.

I (we), the grantor(s) herein, am (are) the owner(s) in fee simple of (an interest in) the following described real estate situated in Skamania County, State of Washington, to wit:

Parcel #02052700120000, 113.7 Acres, E1/2 of SW1/4 and SE1/4 of NW1/4, S27, T2N, R5E of W.M.

on which the grantor(s) owns and operates a spring and waterworks supplying water for public use, located on said real estate, at:

A 200 foot radius protective area centered at a point located approximately 906 feet west and 102 feet south from the center of Section 27, Township 2N, Range 5E of the Willamette Meridian, said center of protective area being further described as the center of a 24 inch diameter concrete manhole at the head works of the spring as shown on the attached map, location of said manhole is further described as being the center manhole of three concrete manholes located 20 feet north of a 24 inch diameter concrete manhole and 75 feet northwest of a 72 inch diameter concrete manhole,


and grantor(s) is (are) required to keep the water supplied from said well free from impurities which might be injurious to the public health.

It is the purpose of these grants and covenants to prevent certain practices hereinafter enumerated in the use of said grantor(s) land which might contaminate said water supply.

NOW, THEREFORE, the grantor(s) agree(s) and covenant(s) that said grantor(s), his (her) (their) heirs, successors and assigns will not construct, maintain, or suffer to be constructed or maintained upon said land of the grantor(s) and within 200 (two hundred) feet of the spring herein described, so long as the same is operated to furnish water for public consumption, any potential source of contamination, such as cesspools, sewers, waste water plumbing, privies, septic tanks, drain fields, manure piles, garbage of any kind or description, barns, chicken houses, rabbit hutches, pigpens, or other enclosures or structures including sheds, garages, or carports for the keeping or maintenance of fowls or animals, or storage of liquid or dry chemicals, herbicides or insecticides, or any other source of contamination not used for operation of said water supply.


