AN ORDINANCE VACATING STRAWBERRY ROAD IN THE CITY OF STEVENSON, WASHINGTON.

WHEREAS, upon a Petition signed by not fewer than two-thirds of the abutting property owners and filed with the City Administrator of the City of Stevenson, the owners initiated the procedure under RCW 35.79.010 for vacating the City of Stevenson right-of-way described on Exhibit "A" attached hereto and incorporated herein, and

WHEREAS, the City Council held a public hearing January 15, 2015 pursuant to legal notice by the Stevenson City Council and the matter of the vacation was considered without objection by members of the public, and

WHEREAS, the Council considered the road's proximity to Kanaka Creek and found it did not "abut" the creek insofar as it had never provided access to the creek and the topography of the area made it unsuitable for creek access. Moreover, Kanaka Creek is a small stream that is not used for navigation or recreation and in that sense it does not constitute a "body of water" under RCW 35.79.035, and

WHEREAS, the Stevenson City Council approved the vacation on the conditions set forth below.

NOW, THEREFORE, the City Council of the City of Stevenson do hereby ordain as follows:

<u>Section 1</u>. The real property described on the attached Exhibit "A" which is incorporated herein is hereby vacated.

<u>Section 2</u>. As a condition to the passage of this vacation ordinance, the owners of the real property vacated shall pay to the City of Stevenson a total sum of Five Hundred Dollars (\$500), representing the City's costs to vacate the road and until said amount is paid to the City in full this ordinance shall not be published or effective.

Section 3. This ordinance shall be effect	tive and published according to law when the condition of
	payment for the vacated property has been met.
