Dear Ms. Gorsage,

The Community Development Department issued an Administrative Decision on November 14, 2007, and a Revised Administrative Decision on November 19, 2007 for the above referenced application. A building permit (file no. BP-293-07) was issued in 2008 and the approved house was constructed. During the NSA final inspection staff identified that the both the well and the on-site septic system were constructed in locations outside of that approved in the NSA Administrative Decision. Additionally, a split rail fence had been constructed without NSA approval. The NSA final inspection was not approved at that time. The purpose of this letter amendment is to review and approve the altered locations of the well and on-site septic system in order for the existing development to be in compliance with the NSA approval. As you have identified in your NSA Letter Amendment application the rail fencing has been removed.

The on-site septic system was originally approved with the septic tank on the south side of the house, and the drain field directly west of the housing. The septic tank was installed on the north side of the dwelling with the drain field located north and slightly west of the house as shown on the site plan. The well was originally proposed approximately 12 feet from the southeast corner of the parcel and was drilled approximately 40 feet from the south property line, and 25 feet from the east property line.

Pursuant to SCC §22.06.080(B), a change or alteration to an approved action, if determined to be minor by the Director, may be "deemed consistent with the provisions of this Title and the findings and conclusions on the original application." The proposed requests constitute a minor change; therefore, the original decision shall be amended as stated above.

The revised site plan (see attached page $\underline{\hspace{1cm}}$) to this Letter Amendment shall replace the one attached to the Administrative Decision. The amendment is hereby approved.

As a CONDITION OF APPROVAL you must record the Revised Administrative Decision for file no. NSA-07-62 (as required by Condition of Approval number one) dated November 19, 2007 and this Letter Amendment in the Skamania County Auditor's Office prior to the release of the building permit for the finishing of the daylight basement (interior work only).


