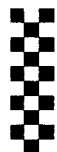

**To Whom It May Concern;**

I, June M.Moore, one of the original owners of Wind River Mining Corporation, hereby recognize my daughter, Patricia L. Ginther as the granddaughter of the original owner, Leo R.Moore,who first struck a claim on the property in July 1, 1938-recorded for record on August 24, 1938. It became later known as the Paradise Group Association. Recorded for record on June 30, 1939. In 1947, Leo turned it over to his son Samuel L. Moore, my husband. On July 7 1952, my husband Samuel and Everett N. Philpott ,renamed the mine The Paradise Mine. Later they added more partners and on 8/29/1956 they incorporated and became known as Wind River Mining Corporation. On January 13, 2007, my daughter Patricia L. Ginther became a board member of Wind River Mining Corporation as 3<sup>rd</sup> Vice President.

On August 31, 2007 Wind River Mining Corporation, after considerable consideration,



decided to dissolve after being voted on by the stockholders. On September 4, 2007, the Moore family decided the mine had been in our family for 69 years and we were not ready to give it up. So on September 4, 2007 the family decided to re-open the mines under the original owners name of Leo R. Moore Mines.

I wanted to make a public record of this information, before I die. I am 82 years old and of sound mind and body.
