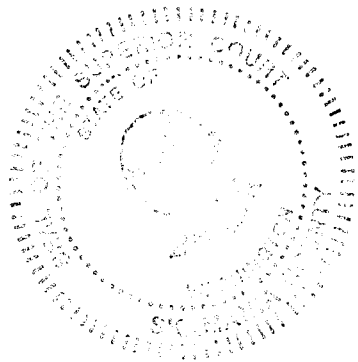

2. For Plaintiff's costs and disbursements incurred herein in the sum of \$118.00.

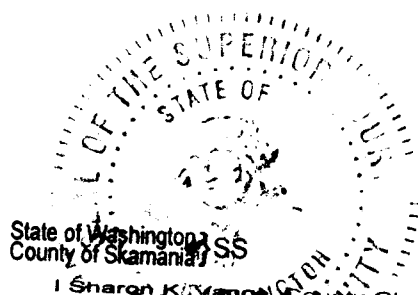
3. For Plaintiff's reasonable attorneys' fees as provided for under RCW 4.84 in the sum of \$200.00.
