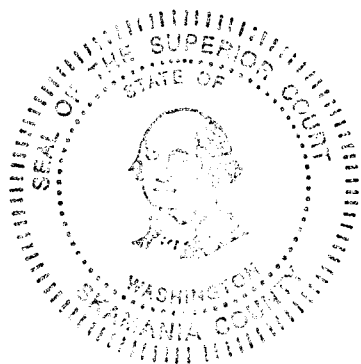

1. For the sum of \$2,821.01, together with statutory interest at the rate of nine percent (9%) per annum from 12/30/2006, through 2/26/2009, in the amount of \$548.82.

2. For the sum of \$1,017.55, together with statutory interest at the rate of nine percent (9%) per annum from 11/19/2003, through 2/26/2009, in the amount of \$483.23.

3. For the sum of \$951.23, together with statutory interest at the rate of nine percent (9%) per annum from 6/30/2004, through 2/26/2009, in the amount of \$399.20.

4. For the sum of \$573.60, together with statutory interest at the rate of nine percent (9%) per annum from 6/25/2003, through 2/26/2009, in the amount of \$293.19.

5. For the sum of \$485.50, together with statutory interest at the rate of nine percent (9%) per annum from 11/16/2003, through 2/26/2009, in the amount of \$230.92.

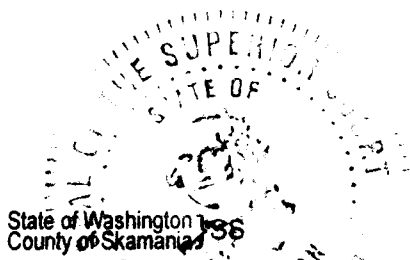
