KNOW ALL MEN BY THESE PRESENTS, that the undersigned James B. Peterson and Ethel B. Peterson, ~~a single person~~-husband and wife, for a good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby grant unto Public Utility District No. 1 of Skamania County, Washington, a municipal corporation of the State of Washington, and to its successors or assigns, the right to enter upon the lands of the undersigned, situated in the County of Skamania, State of Washington, and more particularly described as follows:

20 acres in E ½ of NE ¼ of NE ¼ Sec 36 Twn 3N R 7 E W.M.

Also

16.4 acres fully described in Skamania County Tax Files Number 4081; Deed Ref. Z-37.

The same being a tract of land approximately 36.4 acres in area, located 1 miles ~~N-S-E-W~~ from the Town of Stevenson Washington, and bound by land owned by J.A. Simons, W.H. Casper and Ed. Canesse.

and to place, construct, operate, repair, maintain, relocate and replace thereon and in or upon all streets, roads or highways abutting said lands and electric transmission or distribution line or system, and to cut and trim trees, shrubbery and grasses to the extent necessary to keep them clear of said electric line or system and to cut down from time to time all dead, weak, leaning or dangerous trees or shrubbery that are tall enough to strike the wires in falling, or that might be or become a fire hazard, and to remove all shrubbery, brush and grasses near the poles that might become a fire hazard.

In granting this easement it is understood that at pole locations only a single pole and appurtenances will be used, and that the location of the poles will be such as to form the least possible interference to farm operations, so long as it does not materially increase the cost of construction.

The undersigned covenants that he is the owner of the above described lands and that the said lands are free and clear of encumbrances and liens of whatsoever character except those held by the following persons: Federal Land Bank Vancouver Branch

It is further understood that, whenever necessary, words used in this instrument in the singular shall be construed to read in the plural and that words used in the masculine gender shall be construed to read in the feminine.

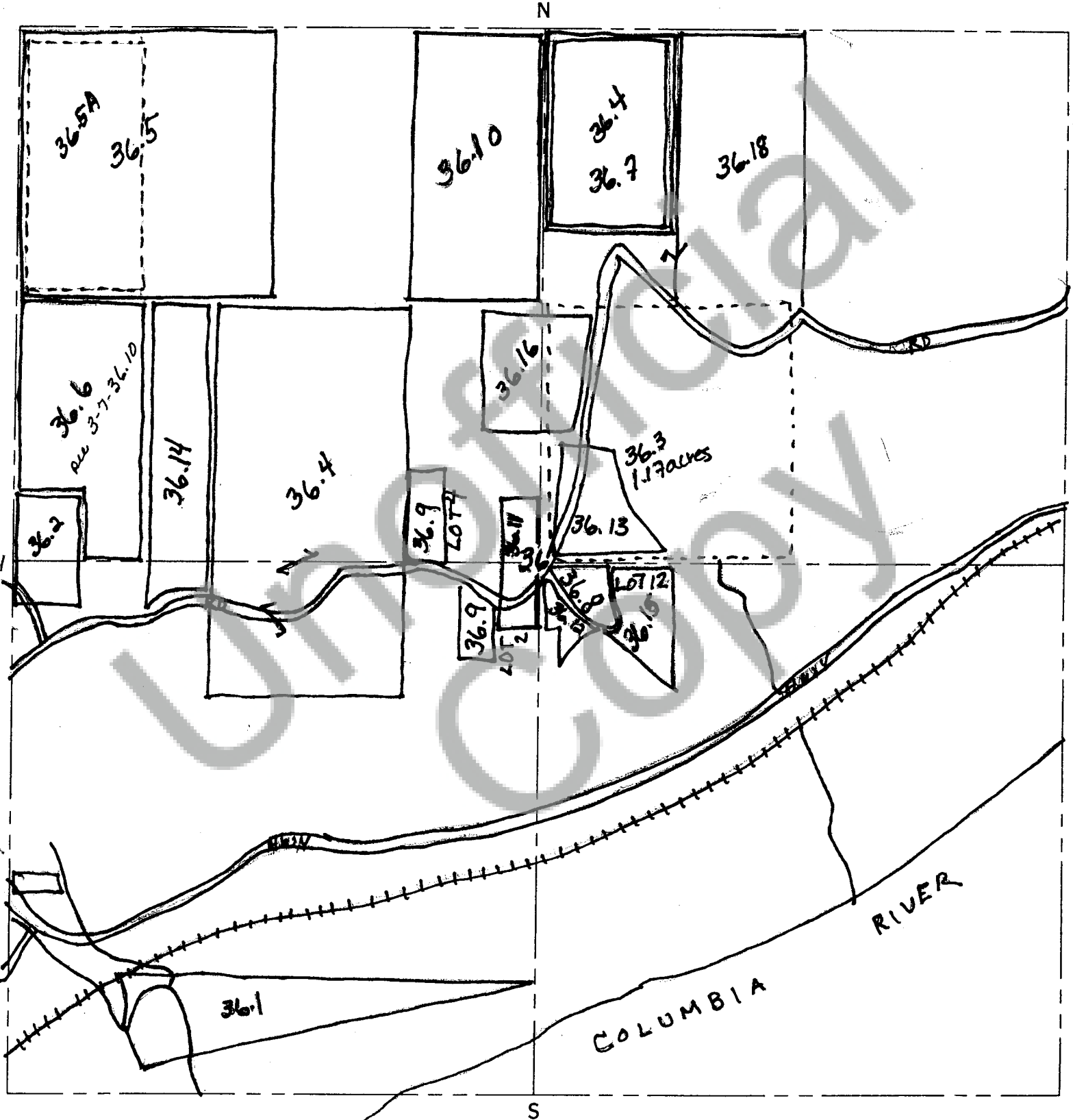
