KNOW ALL MEN BY THESE PRESENTS, that the undersigned a single person—husband and wife, for a good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby grant unto Public Utility District No. 1 of Skamania County, Washington, a municipal corporation of the State of Washington, and to its successors or assigns, the right to enter upon the lands of the undersigned, situated in the County of Skamania, State of Washington, and more particularly described as follows: All Bradford DLC except that belonging to Cascade RR Co. used as RRW known as Old Portage Road. Except also RR-h/w and all land southerly from S.P. & S. being S & W of E & W center line of Sec. 11-2-7. Also undivided  $\frac{1}{4}$  int. in SW $\frac{1}{4}$  Baughman DLC EXCEPT RR-h/w. Also shorelands from E & W center line of Sec. 11 easterly on the front of Baughman DLC

the same being a tract of land approximately 199 acres in area, located 1 miles N-S-E-W from the Town of Stevenson, and bound by land owned by \_\_\_\_\_ and \_\_\_\_\_ and to place, construct, operate, repair, maintain, and replace thereon and in or upon all streets, roads or highways abutting said lands an electric transmission or distribution line or system, it being understood and agreed that said transmission and/or distribution line shall be located approximately as the same is now surveyed and staked upon said ground, and as indicated on the attached plat; and to consist of approximately ✓ pole locations and ✓ anchor locations, and to cut and trim trees, brush and grasses to the extent necessary to keep them clear of said electric line or system and to cut down from time to time all dead, weak, leaning or dangerous trees or brush that are tall enough to strike the wires in falling, or that might be or become a fire hazard, and to remove all brush and grasses near the poles that might become a fire hazard.

In granting this easement it is understood that at pole locations only a single pole and appurtenances will be used, and that the location of the poles will be such as to form the least possible interference to farm operations, so long as it does not materially increase the cost of construction.

The undersigned covenants that he is-are the owner of the above described lands and that the said lands are free and clear of encumbrances and liens of whatsoever character except those held by the following persons:

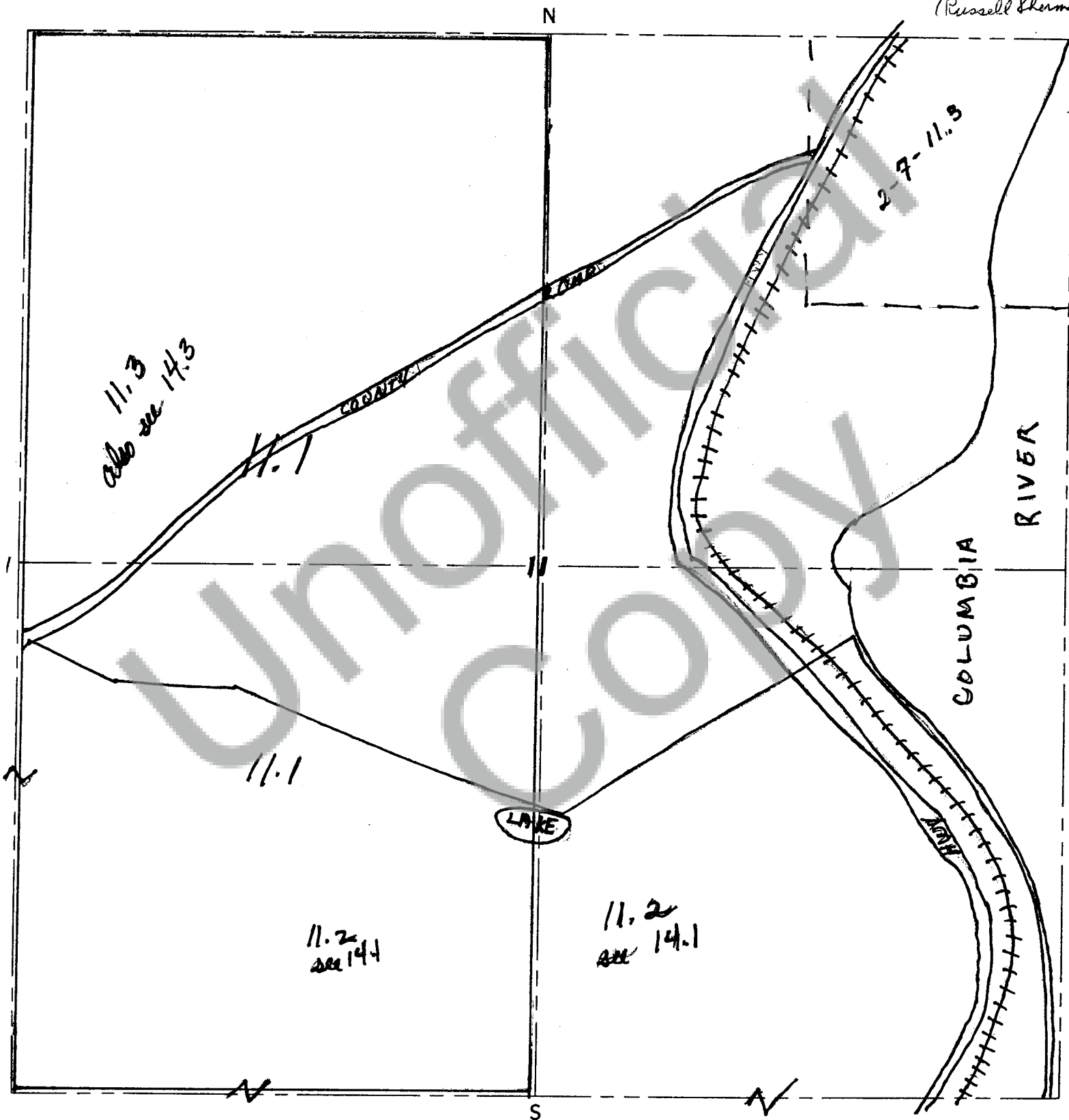
