Dear Ms. Wunsch,

The Community Development Department issued a final Administrative Decision on October 29, 2015, for the above referenced application, NSA-14-39. On March 14, 2016, we received a NSA Letter Amendment Application which proposes minor modifications to the approval.

The original decision included approval to construct a new kitchen shelter (30 ft. \times 22 ft.) and an 80 ft. \times 5 ft. asphalt trail in the Beacon Rock State Park day use area. The new asphalt trail is the primary access to the new kitchen shelter and connects to an existing asphalt trail which accesses the parking lot and other areas of the park.

You are now proposing to construct an additional trail which would create a more direct connection to the parking lot from the new kitchen shelter. This new trail is intended to discourage the creation of unsanctioned trails by park patrons by providing a more direct alternative route. This new trail would be approximately 5 ft. wide and 250 ft. long and surfaced in gravel. Vegetation removed for the trail construction consists primarily of native and non-native grasses, Himalayan blackberry, and some landscaping of snowberry. Once vegetation and the duff layer is cleared, the ground will require minimal grading and compaction of the uppermost surface. Approximately 30 cubic yards of 3/4 minus crushed gravel will be laid and compacted to complete the trail. The attached site plan shows the location of the newly proposed trail.

Pursuant to SCC §22.06.080(B), a change or alteration to an approved action, if determined to be minor by the Director, may be "deemed consistent with the provisions of this Title and the findings and conclusions on the original application." The proposed trail constitutes a minor change and is consistent with the findings and conclusions in your original application; therefore, the original decision shall be amended as stated above.

The modified site plan attached to this Letter Amendment (see pg. 7) shall replace the site plan attached to the Administrative Decision. The amendment is hereby **approved**. All of the original conditions in the Administrative Decision are still valid and applicable to this development. **This letter amendment shall be recorded at the County Auditor's office prior to commencement of construction**. Please find enclosed the application for a Letter of Amendment for a proposed modification to permit # NSA-14-39, construction of a kitchen shelter in the day use area at Beacon Rock State Park. Please find enclosed modified site plans and a permit fee check

Minor Modification Request:

WSPRC proposes to construct a 250' x 5' gravel trail for pedestrian access from the parking area to the backside of the kitchen shelter. Please see the attached site plan dated 3-7-16.

After visiting Beacon Rock this past week, we noticed that all of the clearing and disturbance for the utilities and the construction access road has unintentionally created a situation where the public will try to access the backside of kitchen shelter from the parking lot. We are concerned that rather than using the paved pathways, some patrons will utilize this cleared area as a social trail in an attempt to shorten the distance between the parking area and the kitchen shelter. Even with restoration of the construction access and replanting, the temptation to cut through the backside of the site will remain.

To limit future disturbance in this area and the creation of unsanctioned trails, we are proposing to construct a 250' x 5' gravel surfaced trail from the backside of the kitchen shelter to the parking area. The trail will partially utilize the disturbed construction access and electrical trench area, and will follow closely to the edge of the parking area for the remainder of the length so as to minimize additional disturbance. Vegetation removal for the trail construction will be minimal. Vegetation removed consists primarily of native and non-native grasses, Himalayan blackberry, and some landscaping of snowberry (see attached). Once vegetation and the duff layer is cleared, the ground will require minimal grading and compaction of the uppermost

surface. Approximately 30 cubic yards of ¼ minus crushed gravel will be laid and compacted to complete the trail. Equipment to be used includes a small bobcat or similar tracked equipment and various hand tools. Dependent upon funding and volunteer availability for construction, the trail will be completed in the summer of 2016.




Modified Site Plan APPROVED WITH NSA-14-39-L1 (WA State Parks)
