1. This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between ADAM W. HIGGS AND SARAH J. LIGHTNER, HUSBAND AND WIFE, as Grantor, to JOAN H.
