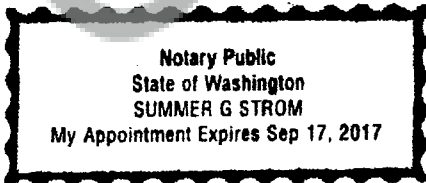

Documentation.

I understand that David D. Wear, Trustee of both of the referenced trusts, has furnished you with copies of the documents used by your parents to establish, and amend, the "John F. Wear & MaryLouise G. Wear Family Trust." If you have not received copies, please let me know and I will send them to you promptly¹. There are no separate documents that pertain to the "MaryLouise G. Wear Testamentary Trust;" that trust was established (for death tax planning purposes) upon the death of your mother pursuant to the terms of the documents used to establish the John F. Wear & MaryLouise G. Wear Family Trust.

Article VIII - Distribution of Assets.

With regard to the distribution of trust assets upon the death of the surviving spouse, Article VIII of the Restated and Amended Trust Agreement, sets forth the terms for distribution of the assets of both trusts.

You will note that your parents did not distribute all of their assets equally among you (the beneficiaries). Your parents were not legally obligated to distribute assets to any of you, or in accordance with any specific formula or method; to my knowledge, the bases for their distribution decisions were known only to them. In any event, in every instance in which I discussed their estate planning wishes with them, and prepared estate planning documents for them, they clearly had the capacity to make decisions concerning the management of the trust and the disposition of the trust assets both during their lifetimes and after the death of the surviving spouse.

The purpose of the enclosed documents is to assign, to Robert D. Wear, the share of stock of Interlaken Resort Company that was issued to my father, John F. Wear in June, 1960.

As your records may reflect, the subject interest in Interlaken Resort Company was originally held by John F. Wear¹, who, in March, 1992, assigned said interest to John F. Wear and MaryLouise G. Wear, as Trustees of the John F. Wear and MaryLouise G. Wear Family Trust UTD 03/26/92. Following the death of MaryLouise G. Wear in, 2012, the subject interest in Interlaken Resort Company was assigned to John F. Wear and David D Wear, as Co-Trustees of the MaryLouise G. Wear Testamentary Trust. John F. Wear passed away on September 6, 2013, and, as part of the administration of the MaryLouise G. CERTIFICATE OF RIGHTS

Pursuant to the understanding with stockholders of the Interlaken Resort Company ("Interlaken") and to a resolution adopted by the Board of Directors of Interlaken on June 6, 1986, this document will evidence the right of Robert Daniel Wear ("stockholder") to construct, maintain, use, own, and control one cabin on Interlaken land so long as such construction, maintenance, and use are in accordance with the rules, regulations, and by-laws of Interlaken and the applicable federal, state, and local laws and regulations. Such cabin may be sold only with a share of Interlaken stock owned by the stockholder, or to another Interlaken stockholder. A condition of the issuance of this certificate shall be the observance by the stockholder of the rules, regulations, and bylaws of Interlaken and the payment of assessments and taxes lawfully imposed.

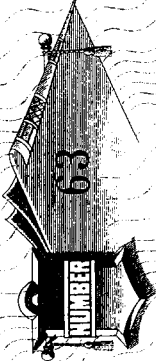

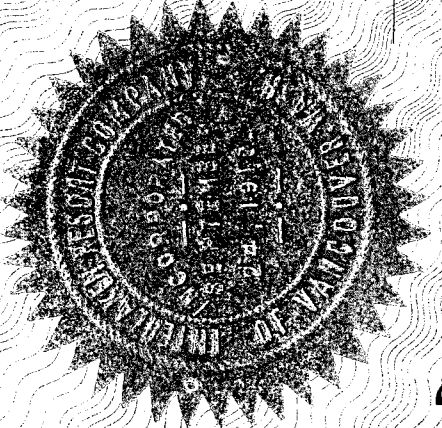
