Bill and Joan Fiedler are responsible for 1/3 cost of electricity and 1/3 cost of maintenance of this well.

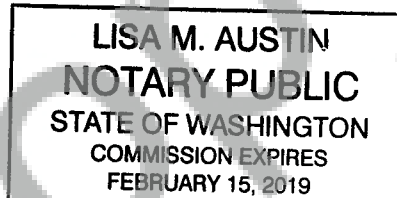
