On September 23, 2016, you were notified that our office had received duplicate 2017 maintenance fee payments in the amount of \$10,230.00. On September 27, you called and instructed us to keep your maintenance fee payments and refund Mr. Fernandez his payments. Also, on that same day, Mr. Fernandez visited our office questioning the duplicate payments because he thought he was the owner of record for these claims with Bureau of Land Management (BLM). We informed him a Quitclaim deed had been filed on September 21, 2015, by you transferring the ownership of the claims from Dan Fer Investment Corp to Mt St Helens Mining and Recovery LTD Partnership. We were informed by Mr. Fernandez that you had no power of attorney or ownership in the Dan Fer Investment Corp enabling you to sell the claims. Mr. Fernandez, submitted documentation showing proof of ownership in the company which is on record with the state of Washington.

Pursuant to 43 CFR 3833.32 the BLM is unable to recognize your interest in the claims. Therefore the quit claim deed submitted to our office on September 21, 2015, is rejected and the claims listed will be reinstated under the ownership of Dan Fer Investment Corp.

In response to your letter received in our office on September 28, 2016, requesting a refund be issued to Daniel Fernandez for \$10,230.00, for payment of 2017 maintenance fees, this will not occur for the above stated reasons. If you do not contact this office in writing by November 1, 2016, your payment will be retained, by the BLM, as a duplicate payment for the current assessment year. If your request is received the BLM will issue a refund in the amount of \$10,230.00 to Jess Minium. The \$10.00 processing fee to file the quit claim deed with BLM is non-refundable (43 CFR 3830.22).

Before the BLM can accept any deed from you, we will need copies of a power of attorney or other legal documentation showing that you have the authority to represent on behalf of Dan Fer Investment Corp., accompanied with the required \$10.00 per claim processing fee to cover the recording of the document.
