INSTRUMENT OF REMOVAL OF TRUSTEE UNDER MORTGAGE AND DEED OF TRUST, dated as of October 10, 2016, among NORTHWEST NATURAL GAS COMPANY (the "Company"), an Oregon corporation, and DEUTSCHE BANK TRUST COMPANY AMERICA, a New York corporation, as Corporate Trustee under the Mortgage and Deed of Trust dated as of July 1, 1946, as supplemented (the "Mortgage"), from Portland Gas & Coke Company (now Northwest Natural Gas Company) to Bankers Trust Company (now Deutsche Bank Trust Company Americas) (the "Corporate Trustee") and R.G. WHEREAS, the parties desire to place of record the removal of the Co-Trustee under the Mortgage (as previously modified and as modified hereby), which was recorded (inter alia) in the Official Records of the County and State shown on the attached Exhibit A.

NOW, THEREFORE, pursuant to Sections 103 of the Mortgage, it is agreed as follows (the terms defined in the Mortgage shall, for all purposes of this instrument, have the meanings specified in the Indenture):

- 1.
