WATER PURCHASE AGREEMENT

THIS AGREEMENT made and entered into this 23 day of July, 1979, by and between GEORGE F. CHRISTENSEN, JR. and ANN CHRISTENSEN, husband and wife, and ROBERT K. LEICK and CLAUDIA J. LEICK, husband and wife, hereinafter called the purchasers and MEL E. STEWART and VERNA M. STEWART, husband and wife, hereinafter called the sellers;

WITNESSETH:

WHEREAS the purchasers previously purchased from the sellers approximately 20 acres of real property pursuant to a real estate contract dated the 5th day of January, 1979, and recorded under Auditor's File No. 87867, Records of Skamania County, Washington;

AND WHEREAS by virtue of the last paragraph of said agreement the purchasers are entitled to 500 gallons per day of water from the sellers,

NOW THEREFORE the parties in pursuance of said paragraph and in modification of the same agree as follows:

- (a) The purchasers shall have the right to purchase two (2) water rights from the sellers. Said water rights to have same rights and duties as all other water rights existing in the Maple Hill Water Company for the sum of One Thousand Five Hundred and No/100 (\$1,500.00) Dollars per water right, and
- (b) The purchasers shall have the option to purchase two (2) additional water rights for the sum of Two Thousand and No/100 (\$2,000.00) Dollars per water right. Said option may be exercised by the purchasers or their assigns at any time during the next five (5) years provided the system has the sufficient quantity to supply the same.
