

Thence **1500** feet to the NW corner (corner No. 4);
Thence **600** feet to the NE corner (corner No. 1 the point of beginning);


The **NORTHEAST** Corner of this claim is **6000** feet **NORTH** and **4800** Feet **EAST** of the **SOUTHWEST** Corner of **Section 33, T4N, R5W, WPM.** The general course of the lode or vein is from the **NORTHERLY** to the **SOUTHERLY** direction.
