The NORTHEAST Corner of this claim is 4500 feet NORTH and 4800 Feet EAST of the NORTHWEST Corner of Section 33, T4N, R5W, WPM. The general course of the lode or vein is from the NORTHERLY to the SOUTHERLY direction. 
