

Thence **1500** feet to the **NW corner (corner No. 4);**  
Thence **600** feet to the **NE corner (corner No. 1 the point of beginning);**

The **NORTHEAST** Corner of this claim is **4500** feet **NORTH** and **7800** Feet **EAST** of the **NORTHWEST** Corner of **Section 33, T4N, R5E, WPM.** The general course of the lode or vein is from the **NORTHERLY** to the **SOUTHERLY** direction. 
