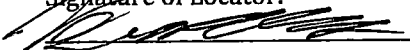
In the **Washougal Mining District** on the **19th** day of **October, 2017**.

Thence **600** feet to the **SW** corner (corner No. 3);
Thence **1500** feet to the **NW** corner (corner No. 4);
Thence **600** feet to the **NE** corner (corner No. 1 the point of beginning);

The **NORTHEAST** Corner of this claim is **1500** feet **NORTH** and **7800** Feet **EAST** of the **SOUTHWEST** Corner of **Section 33, T4N, R5E, WPM**. The general course of the lode or vein is from the **NORTHERLY** to the **SOUTHERLY** direction. The **Lode Mining Claim** is approximately **1500** feet long and **600** feet wide, such that **1480** feet are claimed in a **NORTH** direction and **20** feet in a **SOUTH** direction from the point of discovery (monument of location) at which the Notice of Location is posted, together with **300 feet** on each side of the point of discovery (monument of location) and center line of the Claim.

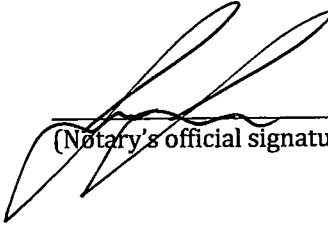
