### AGRICULTURAL LABOR HOUSING AGREEMENT

The undersigned, on behalf of his/herself, his/her heirs, successors and assigns, agrees to the following:

WHEREAS, approval to permit construction of agricultural labor housing at 31 Memory Lane, Underwood, WA, 98651 and identified as Skamania County parcel #03-10-16-0-0-1101-00 is dependent on the conditions of approval issued for Skamania County National Scenic Area Land Use Application NSA-15-10;

WHEREAS, limitations on the use and occupancy of the agricultural labor housing were issued as a condition of approval for Skamania County National Scenic Area Land Use Application NSA-15-10;

NOW THEREFORE:

**The agricultural labor housing shall only be occupied by agricultural laborers employed to labor on the subject property. The agricultural labor housing shall only be used seasonally and seasonal use shall not exceed nine months.**
