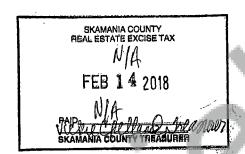

COMMUNITY PROPERTY AGREEMENT

WITNESSETH:

In consideration of the love and affection that each of said parties has for the other, and in consideration of the mutual benefits to be derived by the parties hereto, IT IS HEREBY AGREED:

- 1. Revocation of Prior Agreements. The parties hereto hereby mutually revoke any prior agreements between them as to the status and disposition of community property as authorized by R.C.W. 26.12.120.
- 2. Property Covered: Except for the property specifically identified below, this Agreement shall apply to all property now owned or hereafter acquired by husband and wife, even though some items may be registered in the name of one or the other or both. Conversion of separate property of either party not excluded from the operation of this Agreement into community property shall occur immediately prior to the death of either of the parties hereto. All other property of the parties hereto other than their respective separate properties, is hereby declared to be community property. Further, each spouse retains the right to deal with or transfer their respective separate property, individually, without the consent of the other spouse, until the separate property of either is converted into community property.
- 3. <u>Property Excluded from this Agreement.</u> The parties declare that there is no property of either party that is excluded from the operation of this Agreement.
 - 4. <u>Vesting at Death of Spouse.</u> If husband or wife survives by ten (10) days the

death of the other, all of the decedent's right, title, and interest in all of the community property, including separate property converted into community property immediately prior to the death of the first spouse to die, and exclusive of property specifically excluded from the operation and effect of this Agreement, shall immediately vest in fee simple in the survivor, provided that the surviving spouse or the surviving spouse's duly authorized representative, including, but not limited to, attorney-in-fact, guardian or personal representative, may disclaim all or any part of the assets or benefits afforded the surviving spouse under the terms and provisions of this Agreement.

5. **Revocation:**

- Provisions of this Agreement shall be automatically revoked upon either spouse filing a petition, complaint or other pleadings for separation, dissolution, or divorce of their marriage, or upon the parties' marriage becoming defunct, as defunct marriages are determined under the laws of the State of Washington.
- This Agreement may be revoked by either party if either party is found b. incompetent or incapacitated as determined by court order, or, either party is determined to be incompetent or incapacitated pursuant to a written opinion of the incompetent or incapacitated party's then attending physician [the determination by the physician is to be followed regardless of the provisions of RCW 11.88.010(c)].
- If either of the provisions of paragraph (b) above apply, the revocation shall be by written declaration rescinding and terminating the Agreement, which written declaration must be acknowledged in the same manner as deeds to real estate. The declaration may be executed by either party or on behalf of either party by said party's duly authorized representatives, including, but not limited to, attorneys-in-fact, trustees, or guardians.
- **Disclaimer:** In the event the surviving spouse, or the surviving spouse's 6. authorized representative, disclaims all or any portion of the assets receivable by the surviving spouse or the benefits afforded to the surviving spouse under the terms and provisions of this Agreement, said assets or the interest or benefits so disclaimed shall pass from the deceased spouse as if this Agreement did not exist.
