DURABLE POWER OF ATTORNEY

- 1. Appointment. I, JAMES D. CHRISTIANSON, reside in the State of Washington and designate THOMAS FOLEY as attorney in fact to act for me as the guardian of my person and property. The validity of this power of attorney shall not be affected by my disability or incompetency.
- 2. General Powers. The attorney in fact, as fiduciary, shall have all the powers of an absolute owner over my assets and liabilities, whether located in or without the State of Washington or located in another country. Without limiting the generality of the foregoing grant of powers, the attorney in fact shall have the power to sell, transfer, pledge, assign, commit, or otherwise dispose of any and all of my real, personal, tangible and intangible assets, including all types of corporate and/or governmental securities and shares of stock and expressly including the power to sell, transfer, convey, mortgage and assign real property.
- 3. Estate Planning Powers.
