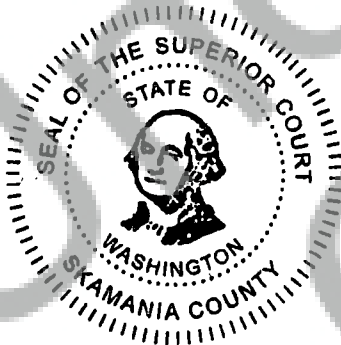

9 composed thereof, as follows:


10 1. For the sum of \$579.25 together with statutory interest at the rate of
