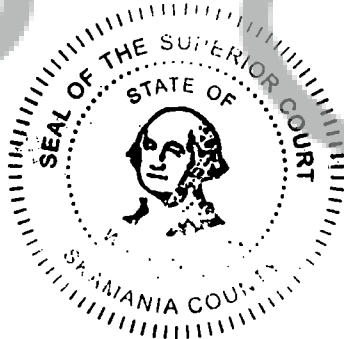

26 \$138.00.


1 7. For Plaintiff's reasonable attorneys' fees as provided for under
