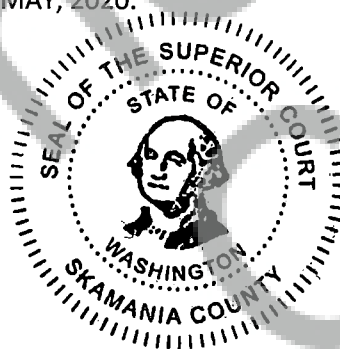

23 of twelve percent (12%) per annum from date of entry until paid.

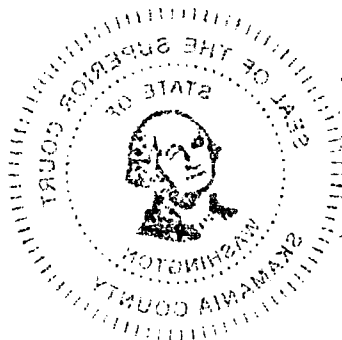
