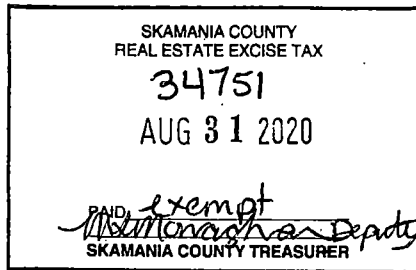

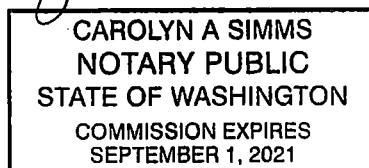

Lot 4 of the "In-Law Acres" Short Plat, according to the recorded Plat Auditor's File No. 2016000851 on May 5th 2016, tract is located in the northwest quarter of northwest quarter of Section 28, Township 3 North, Range 8 East of the Willamette Meridian in Skamania County, Washington.

TOGETHER WITH a portion of Lot 3 of the "In-Law Acres" Short Plat, according to the recorded Plat Auditor's File No. 2016000851 on May 5th 2016, tract is located in the northwest quarter of northwest quarter of Section 28, Township 3 North, Range 8 East of the Willamette Meridian in Skamania County, Washington, being more particularly described as follows:

Beginning at a 5/8" iron rod, L.S.43141 monumenting the northeast corner of Lot 4 of said "In-Law Acres" Short Plat; thence South 00°18'32" West along the east line of said Lot 4 a distance of 164.86 feet to a 5/8" iron rod monumenting the southeast corner, being a point on a curve concaved southwest whose chord bears South 62°49'51" East a distance of 50.02 feet. Radius point measures 55.00 feet. Thence along said curve through the central angle of 54°05'57" a distance of 51.93 feet to a 5/8" iron rod, L.S.18731, being a point of said curve concaved southwest whose chord bears South 25°51'48" East a distance of 19.26 feet. Radius measures 55.00 feet. Thence along said curve through the central angle of 20°10'19" a distance of 19.36 feet to a similar 5/8" iron rod, L.S.18731; thence South 89°53'56" East a distance of 152.06 feet to the southeast corner of Lot 3 of "In-Law Acres" Short Plat; thence North 00°20'52" East along the east line of said Lot 3 a distance of 203.56 feet to a 5/8" iron rod, L.S.15025; thence North 89°30'12" West a distance of 117.11 feet to a 5/8" iron rod, L.S.9025; thence North 89°31'43" West a distance of 88.21 feet to the point of beginning.
