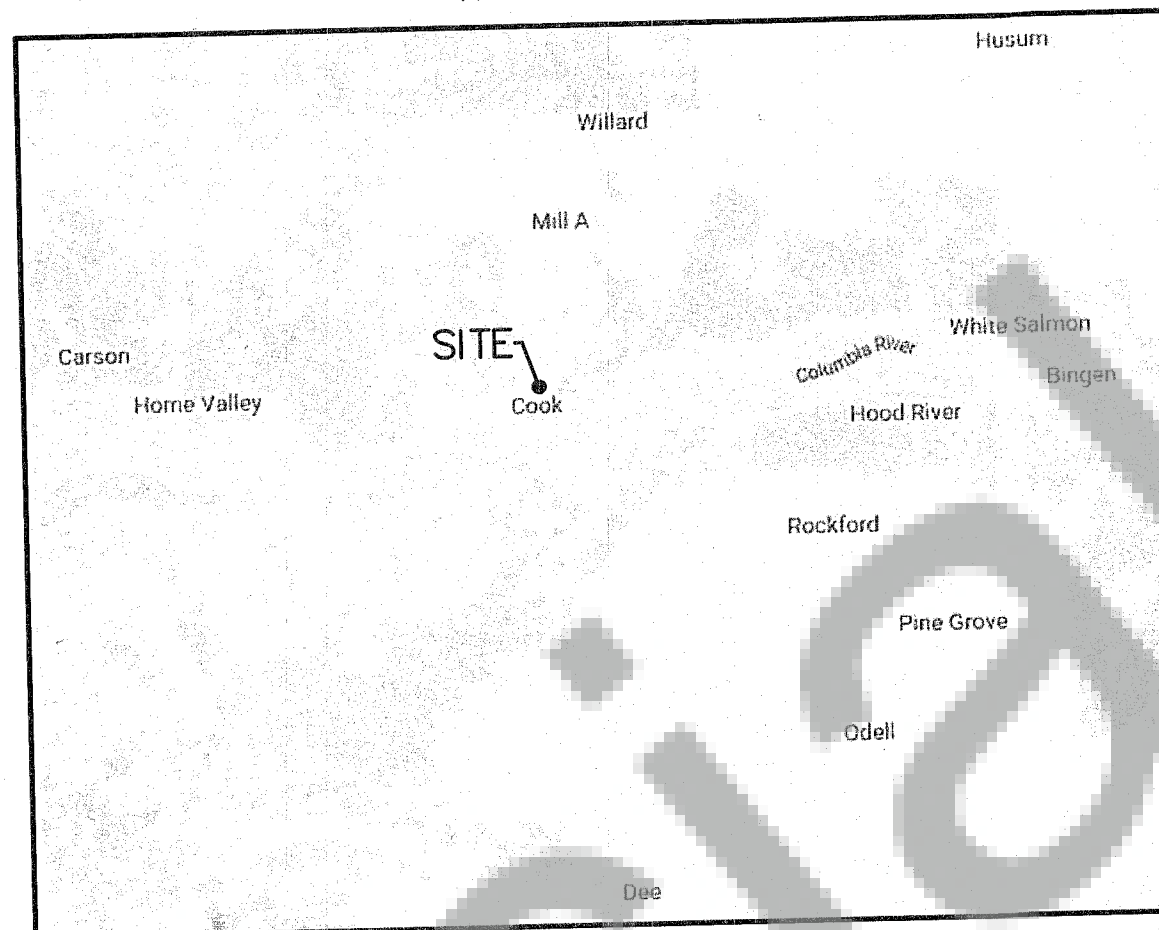




VICINITY MAP NOT TO SCALE

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO MARK AND POST BOUNDARY LINES, MAINTAIN EXISTING CORNERS AND SET NEW BOUNDARY CORNERS FOR THE UNITED STATES FOREST SERVICE UNDER CONTRACT NO. 1205G119F0020 ISSUED IN MAY 2019. THE PROJECT IS LOCATED WITHIN A PORTION OF THE COLUMBIA RIVER GORGE NATIONAL SCENIC AREA AND LOCATED IN THE SE 1/4 AND THE SW 1/4 OF SECTION 27 AND THE NE 1/4 AND NW 1/4 OF SECTION 34, TOWNSHIP 3 NORTH, RANGE 9 EAST, WILLAMETTE MERIDIAN, SKAMANIA COUNTY, WASHINGTON.

THENCE ALONG THE NORTH LINE OF SAID "JOHNSON" PARCEL IN A NORTHWESTERLY DIRECTION TO A 1/2" IRON PIPE (SEE CORNER NO. 223) THAT WAS FOUND AND HELD FOR THE NORTHWEST CORNER THEREOF. THENCE IN A SOUTHWESTERLY DIRECTION ALONG THE WESTERLY LINE OF SAID "JOHNSON" PARCEL BY HOLDING THE DEED ANGLE 93°20'00" (DEED REFERENCE NO. 1 AND NO. 2) TO THE NORTHERLY RIGHT-OF-WAY LINE OF COOK-UNDERWOOD ROAD AS EXISTED ON AND PRIOR TO JANUARY 25, 1946 PER DEED REFERENCE NO. 1 AND NO. 2 AND SHOWN PER SURVEY REFERENCE NO. 8 DATED JANUARY 2, 1917 AND SET A 3-1/2" ALUMINUM FOREST SERVICE CAP (SEE CORNER NO. 270) AT THE CALCULATED POSITION. WE MARKED AND POSTED LINE ALONG THE EAST LINE OF SAID UNITED STATES OF AMERICA PARCEL NO. 03092740020000 BETWEEN FOUND AND HELD CORNERS NO. 212 AND NO. 224. THE NORTHERLY LINE OF SAID "JOHNSON" PARCEL BETWEEN FOUND AND HELD CORNERS NO. 224 AND NO. 223 AND THE WESTERLY LINE OF SAID "JOHNSON" PARCEL BETWEEN FOUND CORNER NO. 223 AND SET RIGHT-OF-WAY MONUMENT NO. 270.

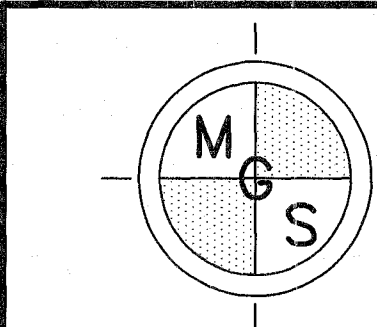
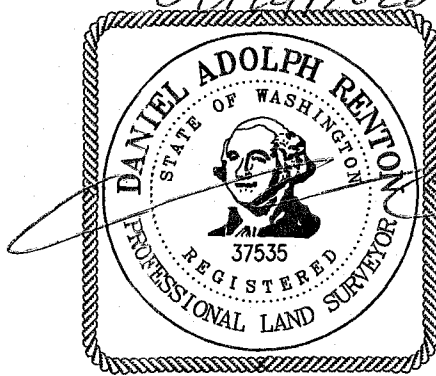
