

SHORT PLAT NOTES

1. THE APPROVED INITIAL, RESERVE AND/OR EXISTING SEWAGE SYSTEM SHALL BE PROTECTED FROM DAMAGE DUE TO DEVELOPMENT. THESE SITES SHALL BE MAINTAINED SO THEY ARE FREE FROM ENCROACHMENT BY BUILDINGS, ROADS AND/OR OTHER STRUCTURE. THESE AREAS SHALL NOT BE COVERED BY ANY IMPERVIOUS MATERIAL AND SHALL NOT BE SUBJECT TO VEHICULAR TRAFFIC OR OTHER ACTIVITY THAT WOULD ADVERSELY AFFECT THE SOIL.

11. LOTS 1 AND 2 ARE SERVED BY A SHARED WELL

A GROUNDWATER STUDY COMPILED BY A HYDROLOGIST, LICENSED IN THE STATE OF WASHINGTON, CONCLUDED THAT, BASED ON ANALYTICAL RESULTS, THERE IS SUFFICIENT QUANTITY AND QUALITY OF WATER AVAILABLE TO SERVE LOT 3 OF THE LIBERTY SHORT PLAT. 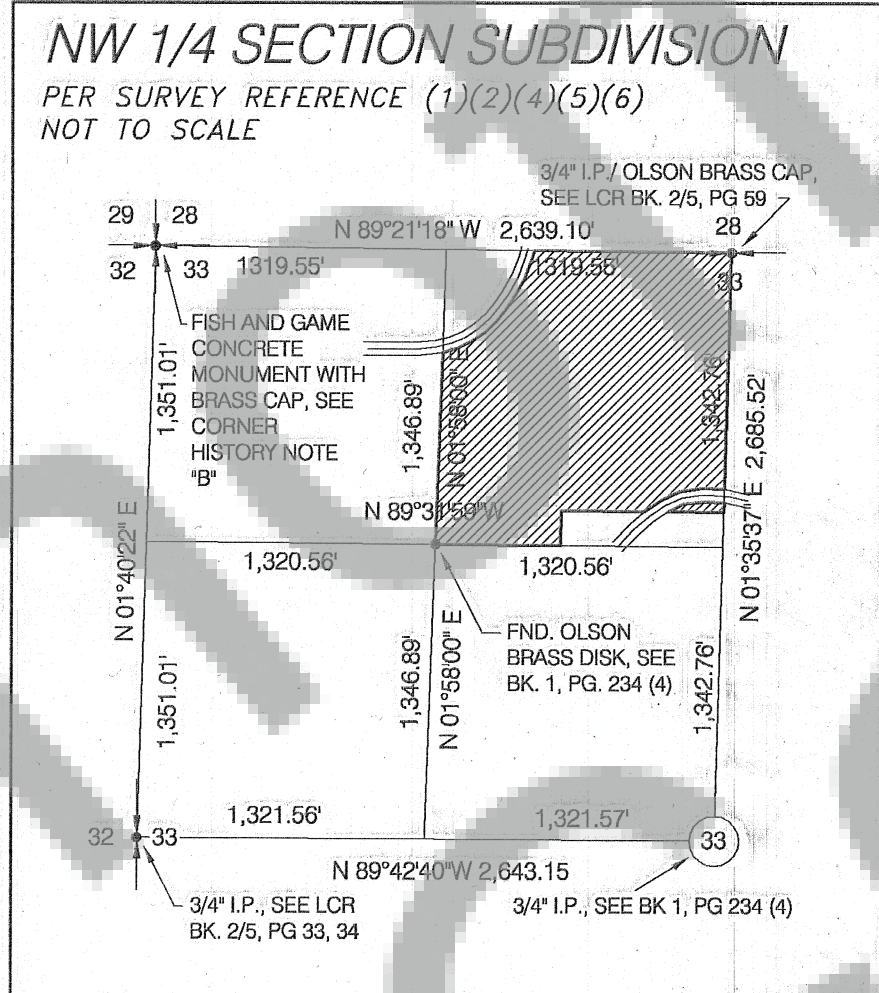

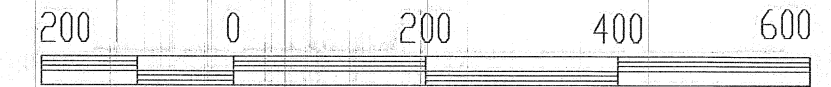

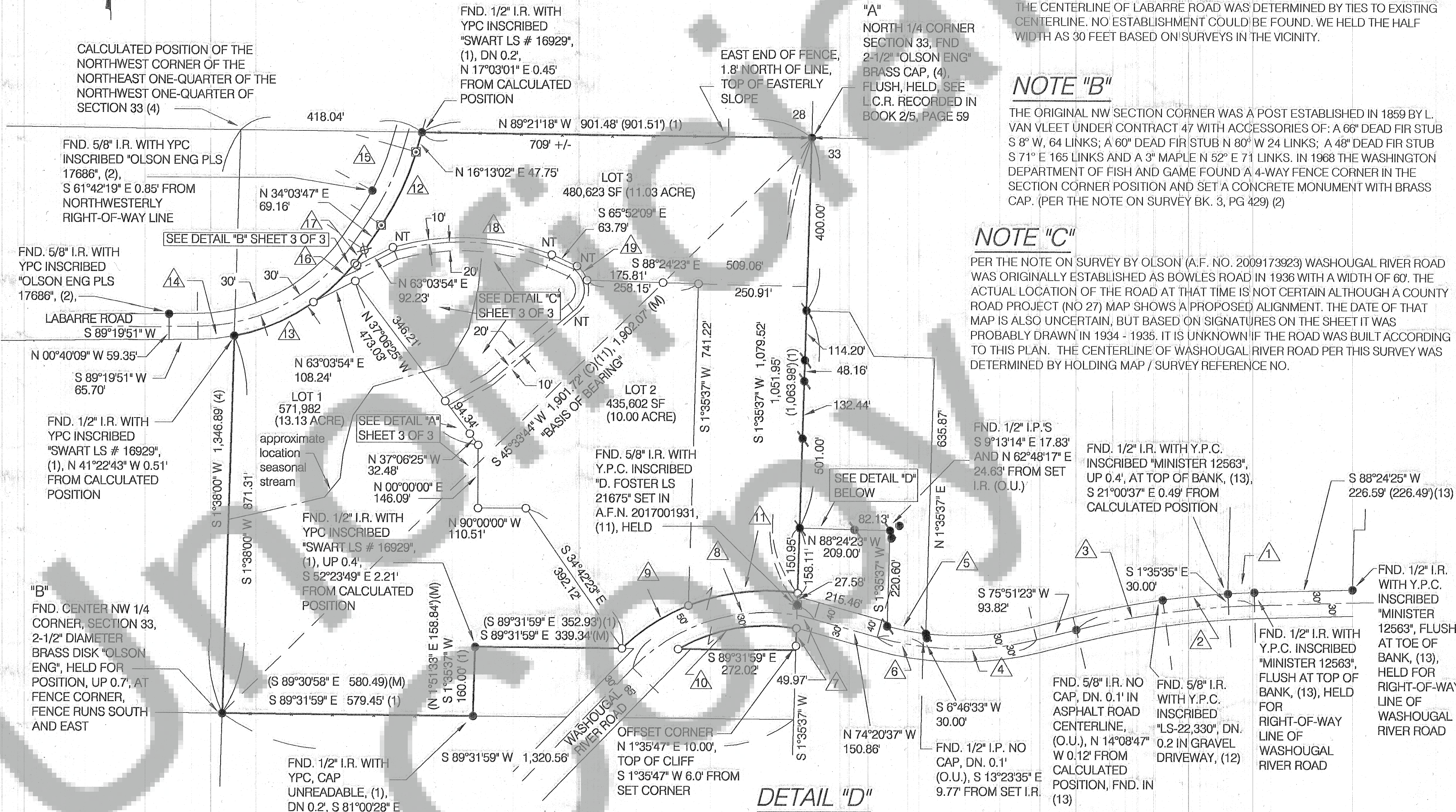
NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO SUBDIVIDE THROUGH THE SHORT PLAT PROCESS THAT PARCEL OF LAND DESCRIBED IN AUDITORS FILE NO. 2017000480, RECORDED MARCH 7, 2017, SKAMANIA COUNTY DEED RECORDS AND SURVEYED PREVIOUSLY BY FOSTER SURVEYING, INC. AND RECORDED IN AUDITORS FILE NO. 2017001931 ON SEPTEMBER 14, 2017. A TRAVERSE WAS RUN TIEING IN ORIGINAL CONTROL FROM OUR PREVIOUS SURVEY AS WELL AS FIELD LOCATING ADDITIONAL FEATURES WITH A FIVE-SECOND TOTAL STATION INSTRUMENT. THE TRAVERSE MET OR EXCEEDED THE STANDARDS CONTAINED IN WAC 332-130-090. FOR THE QUARTER - QUARTER SECTION BREAKDOWN I HELD THE PREVIOUS SURVEYS OF RECORD (3)(4), AS WELL AS OUR PREVIOUS SURVEY (SURVEY REFERENCE NO. 11). THE PREVIOUS RECORD OF SURVEY PERFORMED BY SWART (BOOK 3, PAGE 25) USED THE SAME BREAKDOWN AND WAS HELD. FOR MY BASIS OF BEARING I HELD THE BEARING BETWEEN THE TWO FOUND MONUMENTS LABELED HEREON AS POINTS "A" AND "B" AS SHOWN ON OUR PREVIOUS SURVEY (AFN 2017001931). THE INTERIOR CORNERS WERE SET PER MY CLIENTS DIRECTION AND AS APPROVED BY THE SKAMANIA COUNTY PLANNING DEPARTMENT IN FILE NO. SP-19-06.

NOTE "A"

THE CENTERLINE OF LABARRE ROAD WAS DETERMINED BY TIES TO EXISTING CENTERLINE. NO ESTABLISHMENT COULD BE FOUND. WE HELD THE HALF WIDTH AS 30 FEET BASED ON SURVEYS IN THE VICINITY.

NOTE "B"

THE ORIGINAL NW SECTION CORNER WAS A POST ESTABLISHED IN 1859 BY L. VAN VLEET UNDER CONTRACT 47 WITH ACCESSORIES OF: A 66" DEAD FIR STUB S 8° W, 64 LINKS; A 60" DEAD FIR STUB N 80° W 24 LINKS; A 48" DEAD FIR STUB S 71° E 165 LINKS AND A 3" MAPLE N 52° E 71 LINKS. IN 1968 THE WASHINGTON DEPARTMENT OF FISH AND GAME FOUND A 4-WAY FENCE CORNER IN THE SECTION CORNER POSITION AND SET A CONCRETE MONUMENT WITH BRASS CAP. (PER THE NOTE ON SURVEY BK. 3, PG 429) (2)

NOTE "C"

PER THE NOTE ON SURVEY BY OLSON (A.F. NO. 2009173923) WASHOUGAL RIVER ROAD WAS ORIGINALLY ESTABLISHED AS BOWLES ROAD IN 1936 WITH A WIDTH OF 60'. THE ACTUAL LOCATION OF THE ROAD AT THAT TIME IS NOT CERTAIN ALTHOUGH A COUNTY ROAD PROJECT (NO 27) MAP SHOWS A PROPOSED ALIGNMENT. THE DATE OF THAT MAP IS ALSO UNCERTAIN, BUT BASED ON SIGNATURES ON THE SHEET IT WAS PROBABLY DRAWN IN 1934 - 1935. IT IS UNKNOWN IF THE ROAD WAS BUILT ACCORDING TO THIS PLAN. THE CENTERLINE OF WASHOUGAL RIVER ROAD PER THIS SURVEY WAS DETERMINED BY HOLDING MAP / SURVEY REFERENCE NO.

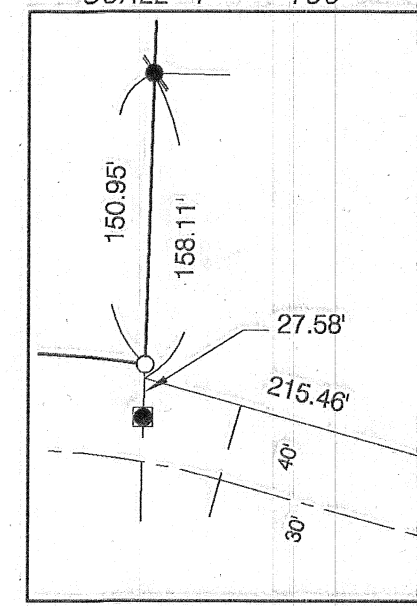

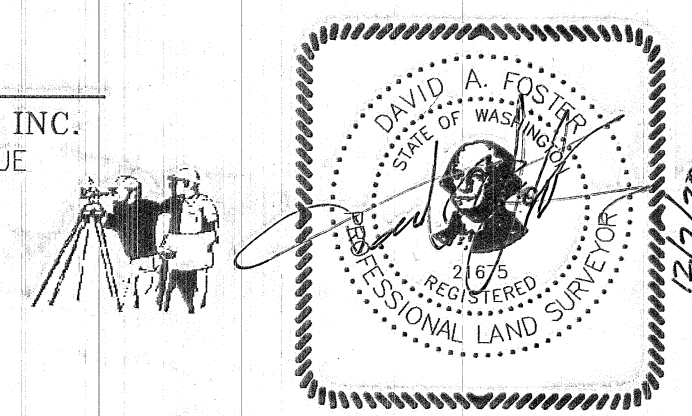

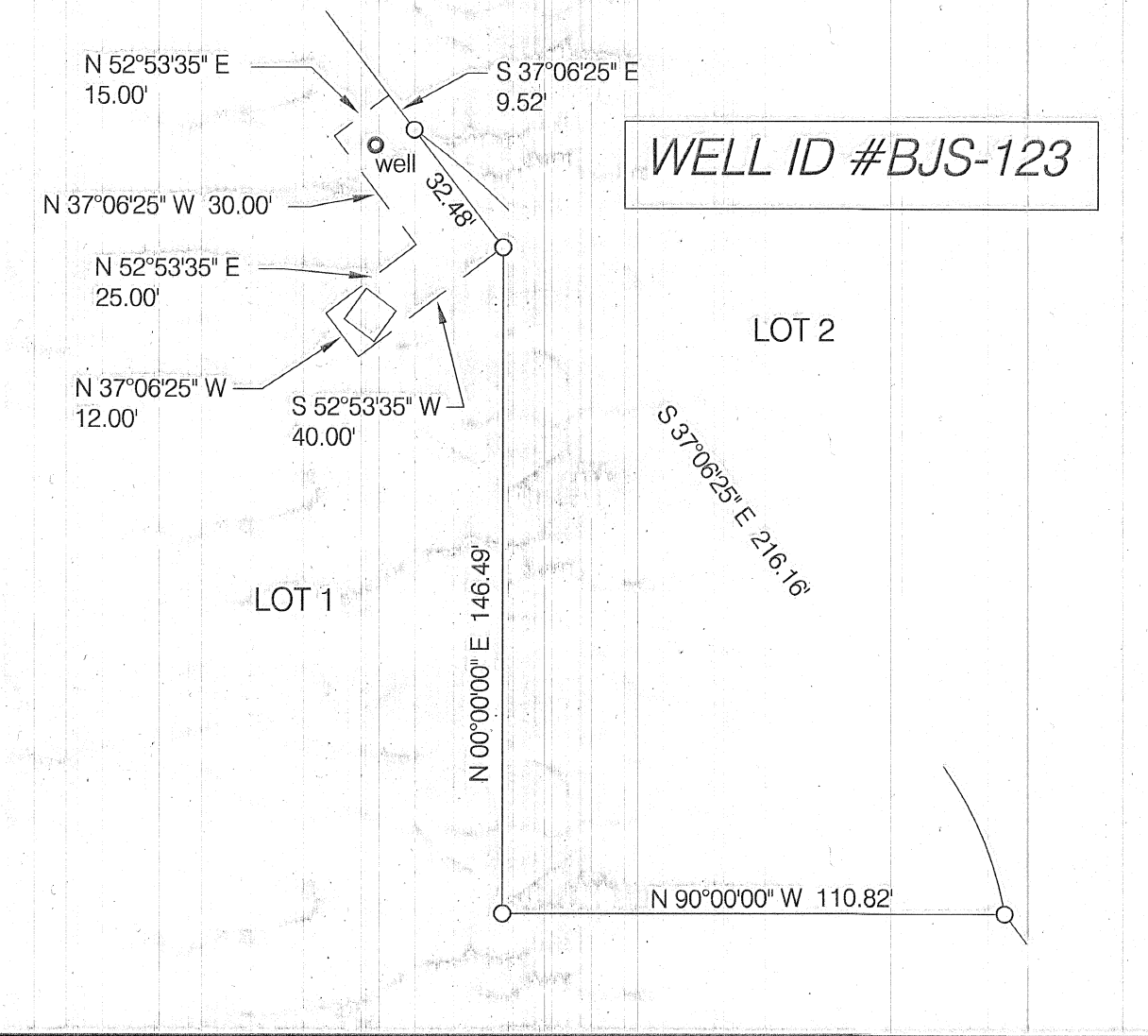

LIBERTY RIDGE SHORT PLAT

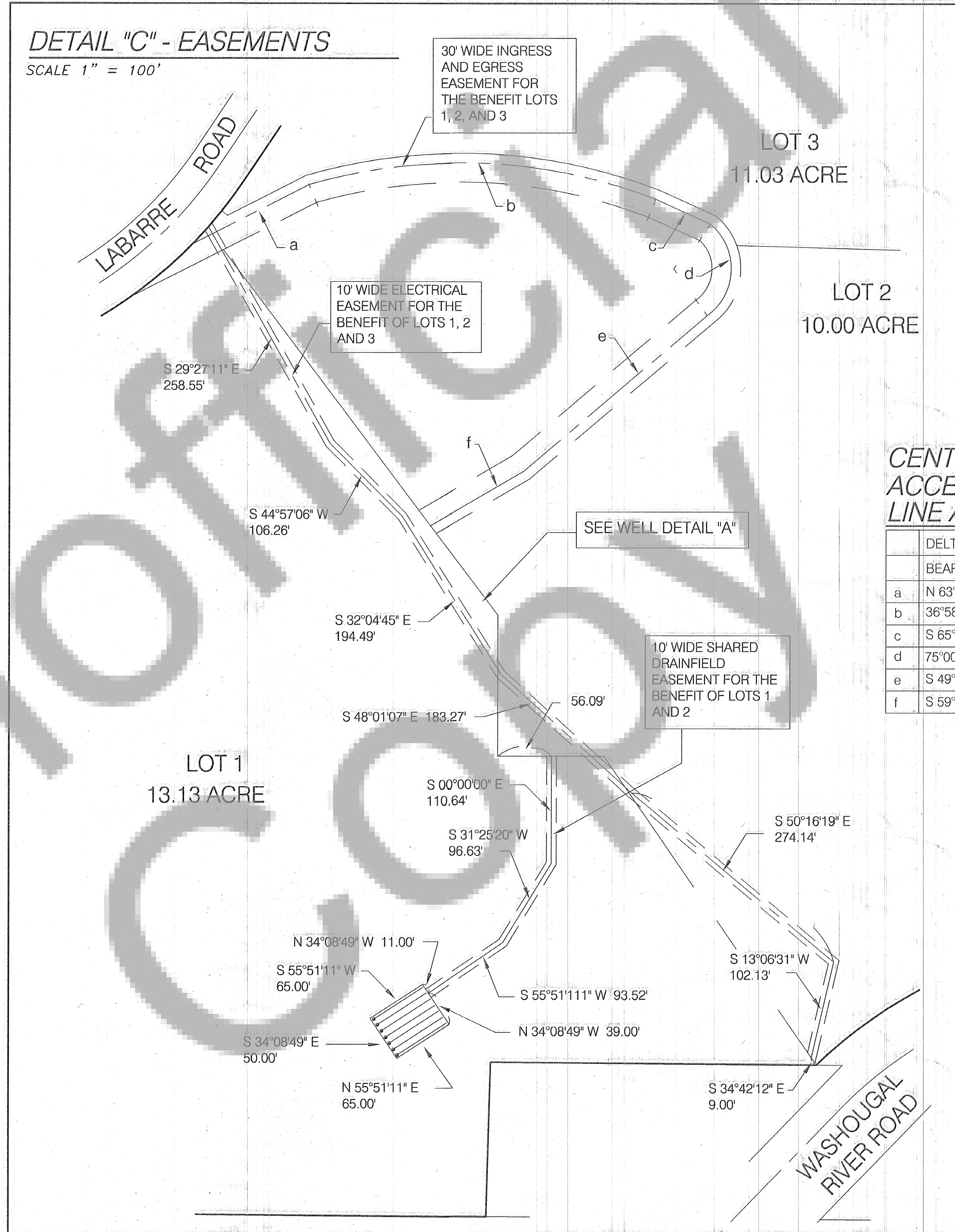

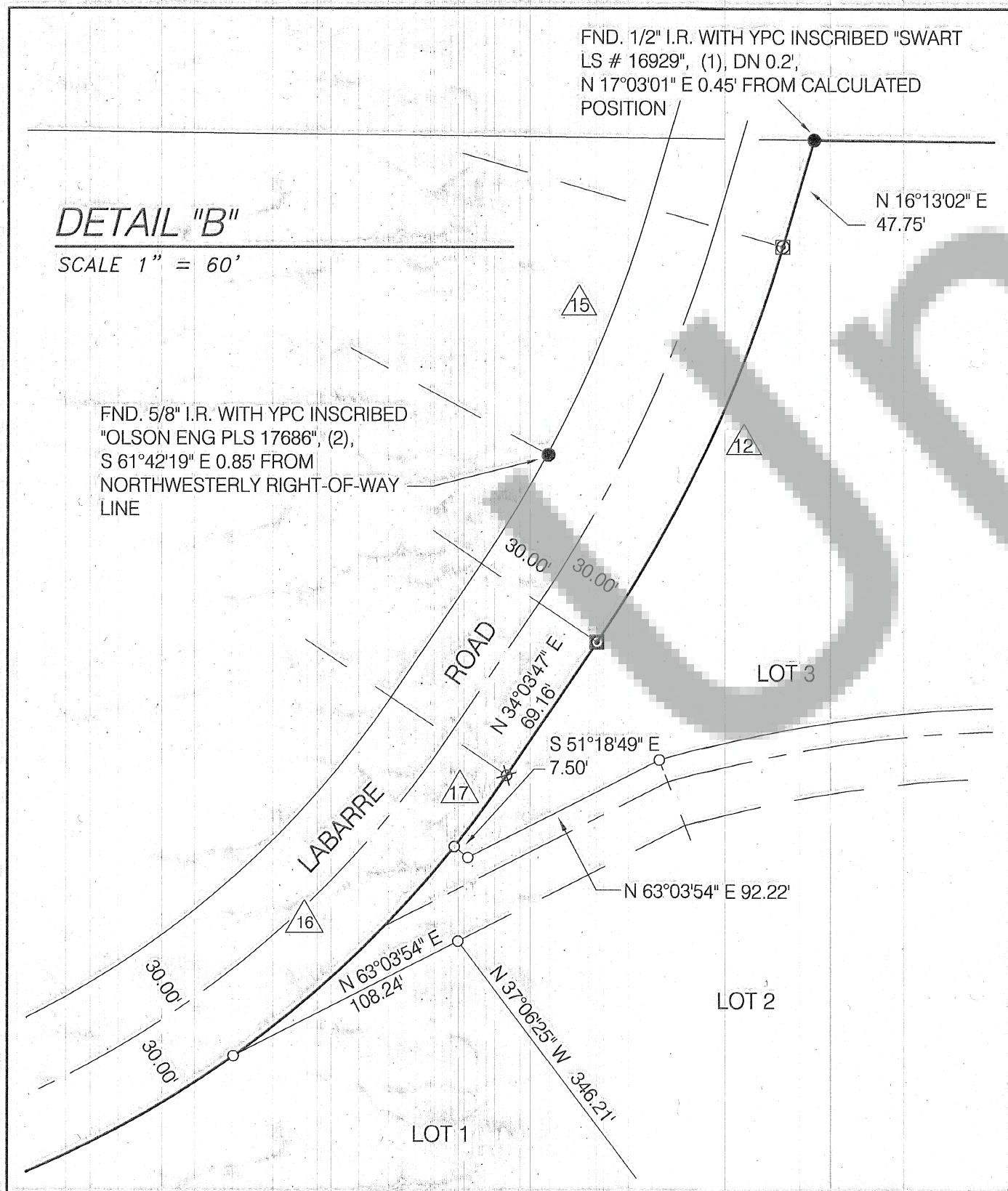

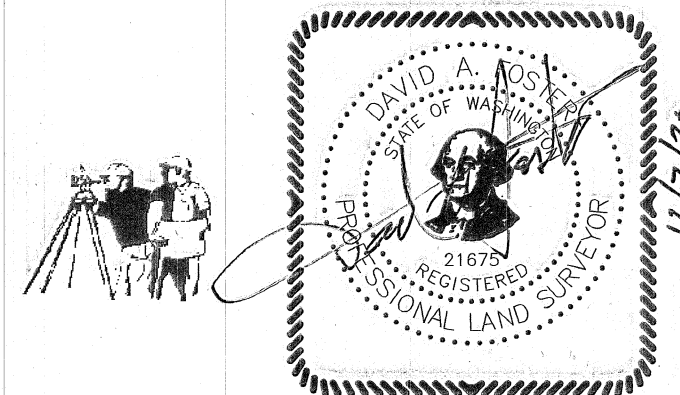
