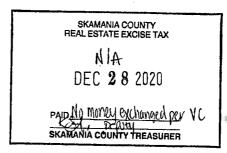

This FIRST AMENDMENT is made this 7<sup>th</sup> day of November, 2020, by Aspen Development, LLC, a Washington limited liability company ("Aspen") ("Declarant").

- A. The original Declaration of Easements, Covenants, Conditions and restrictions for Chinidere Subdivision was executed on September 16, 2008 and recorded on January 12, 2009, AFN 2009171847 (the "Declaration") and the Amended and Restated Declaration was executed November 9, 2015 and recorded on November 10, 2015, AFN 2015002303 (the "Amended and Restated Declaration").
- B. Chinidere, LLC was the prior owner of Lot 2 of Feliz Short Plat (*i.e.*, Phase IV of the Chinidere Mountain Estates Subdivision), and held rights as a declarant authority pursuant to the Declaration, but has since sold that Lot 2 and did not record any assignment of its declarant rights pursuant to the Declaration.

- C. Accordingly, Aspen is the sole Declarant and sole member of Class B voting rights, and still holds all voting rights in the Association, and retains the right to modify the Declaration at any time.
- D. To best complete the development of the Property, Declarant desires to amend the Amended and Restated Declaration pursuant to Sections 7.6 to extend the date of termination for Class B voting rights.

NOW, THEREFORE, Declarant hereby declares the following:

## **DECLARATION**

- A. Section 8.3 is hereby amended and restated as follows:
- 8.3 Voting Rights. The Association shall have two classes of voting membership:
- **8.3.1** Class A. Class A members shall be all Owners, including Declarants, to the extent Declarants own any Lots.
- 8.3.2 Class B. The Class B member shall be the Declarants and their successors and assigns. Class B membership shall terminate upon the happening of any of the following events, whichever occurs earlier: (1) five years after the date of recording of this First Amendment to the Amended and Restated Declaration; (2) such earlier date as Declarants may elect to terminate such membership.

Until the Class B membership is terminated as provided above, all voting rights in the Association shall belong to the Class B members, except to the extent otherwise expressly provided herein. Upon termination of the Class B membership, all voting rights in the Association shall belong to the Class A members, including Declarants. On all matters upon which the Class A members are entitled to vote, such Class A member shall have one vote for each Lot owned within the Property. When more than one person holds an interest in any Lot, all such persons shall be members. The vote for such Lot shall be exercised as they among themselves determine, but in no event shall more than one vote be cast with respect to any Lot.

**B.** All other Articles, sections, and subsections of the Amended and Restated Declaration remain in full force and effect.
