I, JEANNE F. KLINGER, a domiciliary of Washington, declare this to be my last will, and I hereby revoke all wills and codicils heretofore made by me.

ARTICLE I. I give and devise all of my property of whatever kind and wherever located that I may own at the time of my death to my beloved spouse, GARFIELD R. KLINGER, if he should survive me by 60 days, then I give and devise the same to my children who survive me by 60 days, per stirpes. If neither my beloved spouse, GARFIELD R. GLINGER, nor my children so survive me, I give my property to those persons who would have inherited my personal property were I to have died 60 days after the date of my actual death, not married, and domiciled in the state of Washington, under the law of the state of Washington in force at that time, the shares and proportions of taking to be determined by said laws.

I do not intend by this will to exercise any powers of appointment which I have or may come to possess.

ARTICLE II. I appoint GARFIELD R. KLINGER, as executor of this will. If for any reason he is unable or unwilling to serve or continue to serve in that capacity, I appoint KATHLEEN M. - (d) To employ attorneys, accountants, and investment advisors, and to act without independent investigation upon their recommendations, and to employ depositaries, proxies, and agents; and to keep any property in the name of an executor or a nominee, with or without disclosure of any fiduciary relationship, or in bearer form;
