QUIT CLAIM DEED

The Grantor, Lorena E. Hollis, a married woman, as her separate property, for and in consideration of adding her spouse to the deed, conveys and quit claims to Clifford H. Hollis and Lorena E. Hollis, husband and wife, Grantees, the following described real estate, situated in the County of Skamania, State of Washington, together with all after acquired title of the Grantor therein:

The Southwest quarter of the Southeast quarter, the West half of the Northwest quarter of the Southeast quarter, the Northeast quarter of the Southwest quarter, and the Southeast quarter of the Northwest quarter of Section 9, Township 4 North, Range 7 East, of the Willamette Meridian, in the County of Skamania and State of Washington.

EXCEPTING THEREFROM a 5.00 acre parcel, more or less, commencing at the northwest corner of said NE1/4 of the SW1/4 of section 9; thence S46°18'39"E 423.13' to a point 30.00' northeasterly, when measured at right angles, of the centerline of Szydlo Road, and the True point of beginning; thence S88°42'35"E 644.16'; thence S01°39'54"W 573.41' to a point 30.00' northeasterly, when measured at right angles, of the centerline of Szydlo Road; thence northwesterly and always 30.00' northeasterly of and parallel to said centerline of Szydlo Road the following courses and distances: Along a 780.00' radius curve to the left 70.82' the long chord which bears N79°31'07"W 70.80'; thence N82°07'11"W 86.05'; thence along a 160.00' radius curve to the right 167.35', the long chord which bears N52°09'21"W 159.82'; thence N22°11'31"W 134.63'; thence along a 630.00' radius curve to the left 314.26', the long chord which bears N36°28'57"W 311.01'; thence N50°46'22"W 142.65' to the true point of beginning. TOGETHER WITH an easement for ingress and egress over the existing road beginning at a point 69' north of the southeast corner of the above described tract of land; thence running in a northerly direction and ending at a point 112' west of the northeast corner of the above described tract of land, and TOGETHER WITH an easement to such water, as a 1.5-inch pipe

will carry, from the well on said parcel; costs of maintaining said well shall be shared equally between the parties.

TOGETHER WITH and SUBJECT TO those easements, conditions and restrictions of record.


