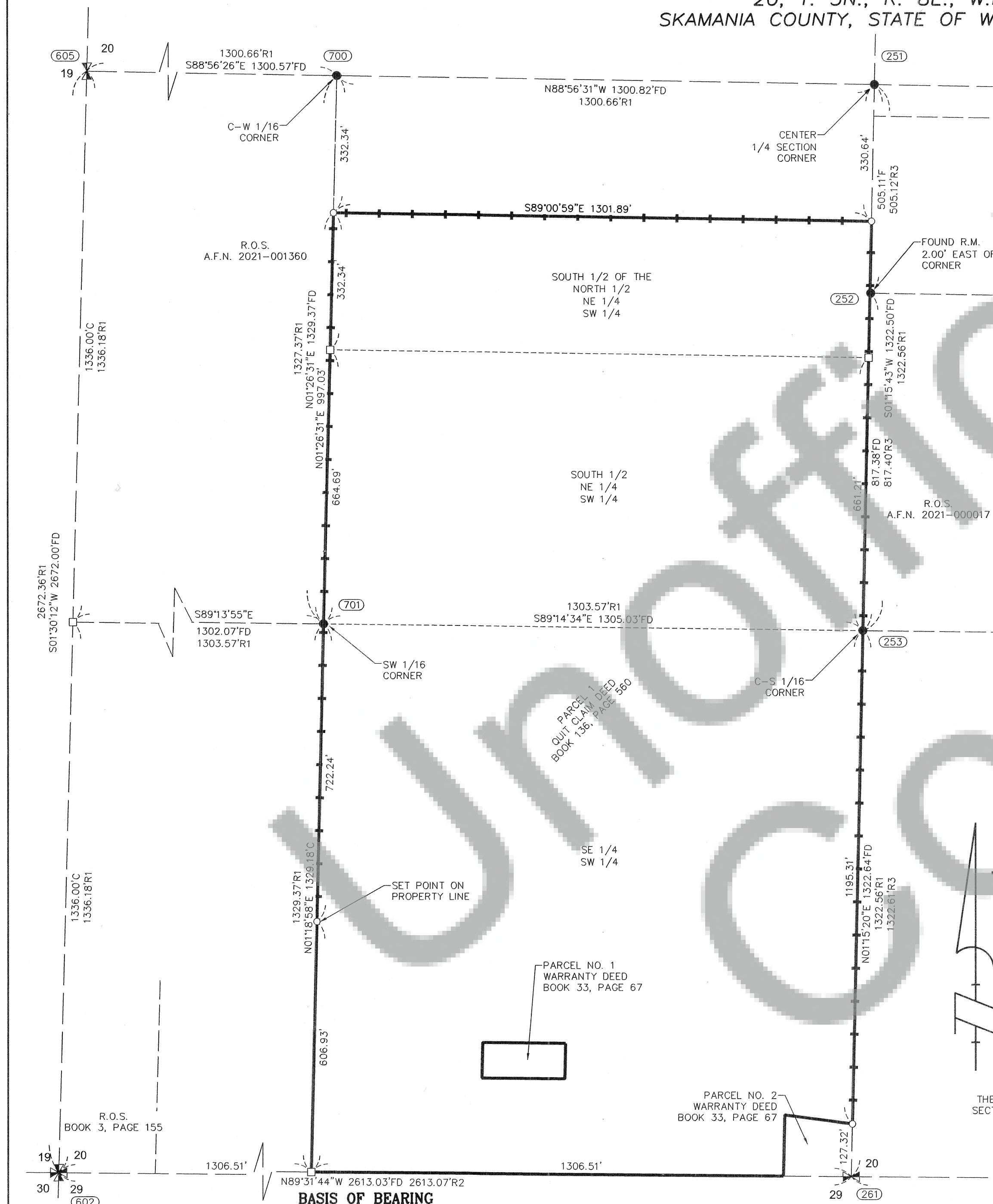


RECORD OF SURVEY

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND MONUMENT THE BOUNDARY OF THAT TRACT OF LAND DESCRIBED IN QUIT CLAIM DEED, BOOK 136, PAGE 560, AS WELL AS MARK A PORTION OF THE BOUNDARY, AS SHOWN, PER THE REQUEST OF CHILTON FOREST MANAGEMENT FOR RAY R. GLUR.

FOR CONTROL, I HELD THE MONUMENTS AS SHOWN ON THIS SURVEY AND DESCRIBED AS FOLLOWS:

THE BASIS OF BEARING ARE FOUND AND HELD MONUMENTS ON THE SOUTH LINE OF THE SW 1/4 OF SECTION 20, PER PER BOOK 1, PAGE 56 OF SURVEYS.

THE SE CORNER OF THE SW 1/4 WAS FOUND AND HELD. THE C-S 1/16 CORNER WAS FOUND AND HELD. THE C 1/4 CORNER WAS FOUND AND HELD. THE S-W 1/16 CORNER WAS FOUND AND HELD. THE SW 1/16 CORNER WAS FOUND AND HELD. THE W 1/16 CORNER COMMON TO SECTIONS 20 AND 29 WAS COMPUTED AT MID POINT BETWEEN THE SW CORNER AND THE SE CORNER OF THE SW 1/4.

A CLOSED LOOP TRAVERSE WAS PERFORMED AROUND THE PERIMETER BOUNDARY

LINE WERE MARKED WITH POSTS AND FLAGGING AS SHOWN ON THIS SURVEY.

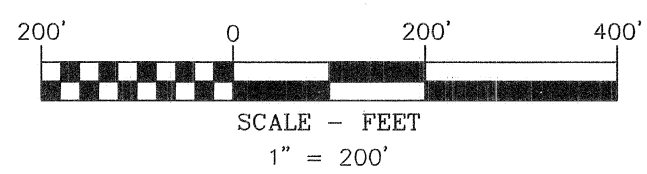
PROCEDURES

RADIAL TIES WITH A TRIMBLE R10 G.P.S. UNIT TO THE SOUTH QUARTER CORNER, CENTER OF SECTION 20, AND THE SOUTHWEST CORNER OF SECTION 20, ALONG WITH A CLOSED LOOP TRAVERSE AROUND THE SUBJECT TRACT WAS PERFORMED USING A TRIMBLE S7 TOTAL STATION AND A TRIMBLE TSC7 DATA COLLECTOR. A LEAST SQUARES ADJUSTMENT WAS MADE, MEETS MINIMUM STANDARDS AS DESIGNATED IN WAC 332-130-090
